RECOMMENDATION

Approve as recommended for each case in the attached packet and transmit to the County Executive for final action.

DISCUSSION

This staff memorandum contains recommendations for category changes requiring action by the County Executive. The Department of Environmental Protection (DEP) staff has submitted the attached package of category change requests on behalf of the County Executive.

The staff reports for administrative cases only highlight those cases where staff recommendations differ from the Executive's recommendation, or where significant comments should be brought to the attention of the Board. There are no significant differences between our recommendations and the cases in this package. This staff report simply transmits the attached package for those cases for consideration of the Planning Board. Planning staff's comments on all cases have been incorporated into DEP's packet along with the comments of other agencies. The full packet for administrative hearings is attached for your consideration or further comment beyond the staff report.

If the Planning Board feels that any of these cases requires County Council action, such action should be requested at this time.

The Department of Environmental Protection has scheduled a public hearing for April 25, 2007. The Board's recommendations will be transmitted to the Executive in time for that hearing. The County Executive will then take final action on the category changes unless the Planning Board has recommended some cases be taken to the County Council.

In all cases the Planning staff recommends that the Planning Board concur with the Executive and transmit these recommendations.

Please be advised that the Montgomery County Department of Environmental Protection (DEP) will hold an administrative public hearing on the following amendments to the County's Comprehensive Water Supply and Sewerage Systems Plan as specified above. The following staff recommendations are at a draft stage as of the posting of this document.

07A-ASP-01 (Saucier):

Property information: 2640 Norbeck Rd., Silver Spring: Flint Hill, P. 575. 0.71 acre. 00964012. HS62. 221NW03. R-200 Zone.

Planning Area and Watershed: Aspen Hill. Northwest Branch. Current and Requested Category/Categories: S-5 to S-1.

WSSC: A 200-foot-long non-CIP-sized sewer extension is required to serve the property. This extension would connect to an existing sewer in Radwick Lane (contract no. 91-9227A) and would abut approximately 2 properties in addition to the applicant's. M-NCPPC: This property is located in the 1994 Aspen Hill Master Plan. It is within the recommended sewer envelope and the R-200 Zone is meant to have community sewer service. Recommendation: Approval of S-1

DPS: A septic repair permit was issued 4/28/77. A satisfactory percolation and water table test was conducted 4/12/77. Records indicate the property had an existing well. **DEP Staff Recommendation and Report: Approve S-3.** Policy V.F.1.a, Consistent with Existing Plans. The provision of public sewer service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies. Sewer service can be provided by a 200' gravity main extension along a public right-of-way.

07A-DAM-07 (Benitez):

Property information: 25106 Oak Dr., Damascus: Montco, 00929805, Lot 8. 0.47 acre 235NW11. FX21. R-200 Zone.

Planning Area and Watershed: Damascus. Little Bennett.

Current and Requested Category/Categories: S-6 to S-1.

WSSC: May be served via a connection to an abutting main; pumped connection recommended to avoid odors.

M-NCPPC: The subject site is in the recommended sewer envelope in the Adopted and Approved Damascus Master Plan 2006. Thus, the provision of community sewer service to this property would be consistent with the master plan. Recommendation: Approval of S-1.

DPS: A septic permit was issued 3/9/56. There is no record of failures for this property. We have had failures in this area and encountered poor soils.

DEP Staff Recommendation and Report: Approve S-1. Policy V.F.1.a, Consistent with Existing Plans. The provision of public sewer service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies. Sewer service can be provided by a pumped connection to an abutting gravity main.

07A-DAM-09 (Weston):

Property information: 8011 Warfield Rd, Gaithersburg: Goshen Estates, Lot 89. 02214834; 2 acres. 228NW08. GU23. RE-2 Zone.

Planning Area and Watershed: Goshen - Woodfield - Cedar Grove. Upper Great Seneca.

Current and Requested Category/Categories: W-6 to W-3.

WSSC: May be served via a connection to an abutting main.

M-NCPPC: The subject site is located within the area of the Preservation of Agriculture and Rural Open Space Master Plan (1980). The applicant's statement requests the category change due to age of well on the property. This category change request will relieve any public health problems created by a failing well. The requested category change is consistent with the intent of the master plan, as the 1980 master plan does not prohibit water service to the RE-2 zone from an abutting main. The master plan was approved prior to the water service policy for large lots (RE-2 zoned properties) in the Comprehensive Water Supply and Sewerage Plan. Water and Sewer Category Recommendation: Approval

DPS: A well and septic system permit was issued 5/9/86. Records indicate 2 wells of insufficient yield were drilled prior to the well system being completed.

DEP Staff Recommendation and Report: Approve W-1. Policy V.F.1.a, Consistent with Existing Plans. The provision of public water service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies for water service to large-lot areas such as the RE-2 Zone. Water service can be provided by a connection to an abutting water main.



07A-DNT-01 (Handy and Snyder LLC):

Property information: 12224 Quince Valley Dr, Gaithersburg: P997 & Outlot A, Quince Orchard Peace & Plenty. 1 acre. 00389471 & 02726077. 221NW12. ES62. R-200/TDR Zone.

Planning Area and Watershed: Darnestown. Muddy Branch.

Current and Requested Category/Categories: (Outlot A is currently W-1, S-1). P997 is requesting S-6 to S-1.

WSSC: Eight-inch sewer lines in Quince Valley Drive and Fellowship Way abut the property (contract no. 86-6764B)

M-NCPPC: Consistent with the Approved and Adopted Potomac Subregion Master Plan (2002). This property is within an older residential area and is within the recommended sewer service envelope. (Page 23) The service will be provided along the roadway and no significant environmental impacts are anticipated. Recommendations: S-1.

DPS: DPS has no record of the existing septic system or documentation of any septic failure.

DEP Staff Recommendation and Report: Approve S-1. Policy V.F.1.a, Consistent with Existing Plans. The provision of public sewer service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies. Sewer service can be provided from an abutting sewer main.

07A-DNT-02 (Pearcy):

Health failure, certified by DPS 08/24/06; expedite letter from DEP/Soukup to WSSC, 08/29/06.

Property information: 15512 Norman Dr, North Potomac: Mountain View Estates.

Lot 11, Block C. 1.03 acres. 00411664. 221NW13. ES42. R-200.

Planning Area and Watershed: Darnestown. Muddy Branch. **Current and Requested Category/Categories:** S-6 to S-1.

WSSC: Can be served via a connection to an abutting main.

M-NCPPC: Consistent with the Approved and Adopted Potomac Subregion Master Plan (2002). This property is within an older residential area and is within the recommended sewer service envelope. (Page 23) The connection is requested due to a documented health problem. The service will be provided along the roadway and no significant environmental impacts are anticipated. Recommendations: S-1

DPS: Septic failure confirmed by DPS – see letter dated 8/24/06.

DEP Staff Recommendation and Report: Approve S-1. Policy V.F.1.a, Consistent with Existing Plans. The provision of public sewer service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies. Although initially identified as a public health problem case, this property is within an area generally intended for public sewer service. Therefore, we recommend an approval without restrictions under the broader "consistent with existing plans" policy. Service can be provided from an abutting sewer main.

Current and Requested Category/Categories: S-6 to S-1.

WSSC: Can be served via a connection to an abutting main.

M-NCPPC: This property is within the planned sewer envelope for Fairland. Thus, the provision of community sewer service to this property would be consistent with the master plan. Recommendation: Approval of S-1. (Fairland Master Plan (1997).

DPS: Septic failures confirmed by DPS- see letters dated 12/3/03 and 10/20/06.

DEP Staff Recommendation and Report: Approve S-1. Policy V.F.1.a, Consistent with Existing Plans. The provision of public sewer service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies. Although initially identified as a public health problem case, this property is within an area generally intended for public sewer service. Therefore, we recommend an approval without restrictions under the broader "consistent with existing plans" policy. Service can be provided from an abutting sewer main.

Current and Requested Category/Categories: S-5 to S-1.

WSSC: Can be served via a connection to an abutting main.

M-NCPPC: This property is within the planned sewer envelope for Fairland. Thus, the provision of community sewer service to this property would be consistent with the master plan. Recommendation: Approval of S-1. (Fairland Master Plan (1997)).

DPS: Septic failure confirmed by DPS-see letter dated 10/20/06.

DEP Staff Recommendation and Report: Approve S-1. Policy V.F.1.a, Consistent with Existing Plans. The provision of public sewer service is consistent with the master plan recommendations and with the Water and Sewer Plan Policies. Although initially identified as a public health problem case, this property is within an area generally intended for public sewer service. Therefore, we recommend an approval without restrictions under the broader "consistent with existing plans" policy. Service can be provided from an abutting sewer main.

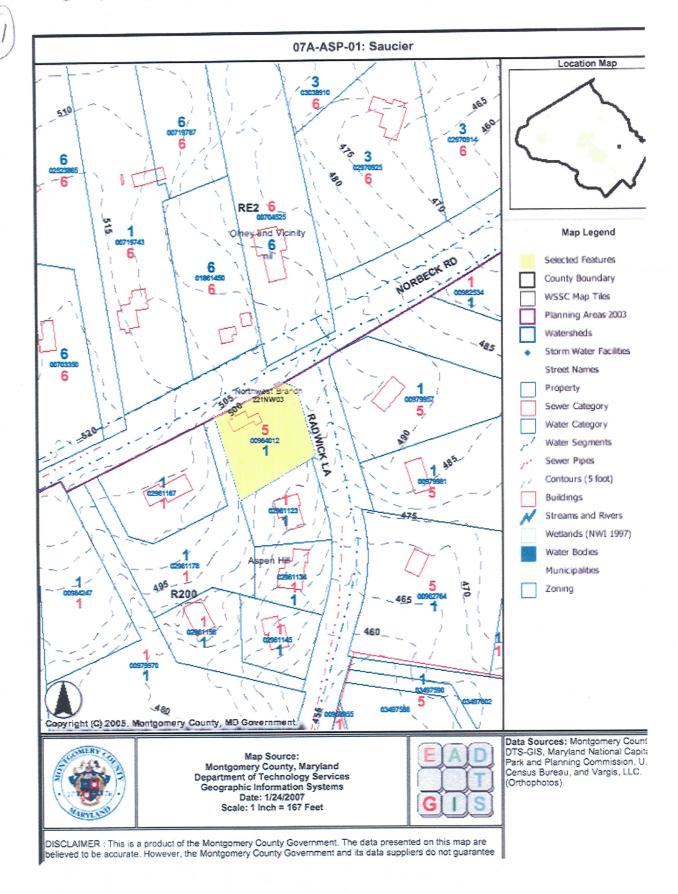

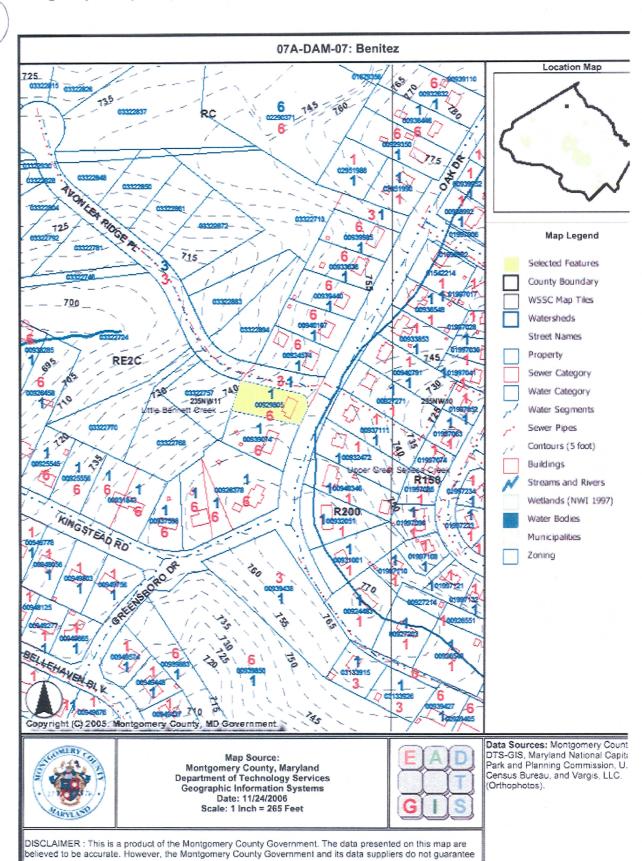

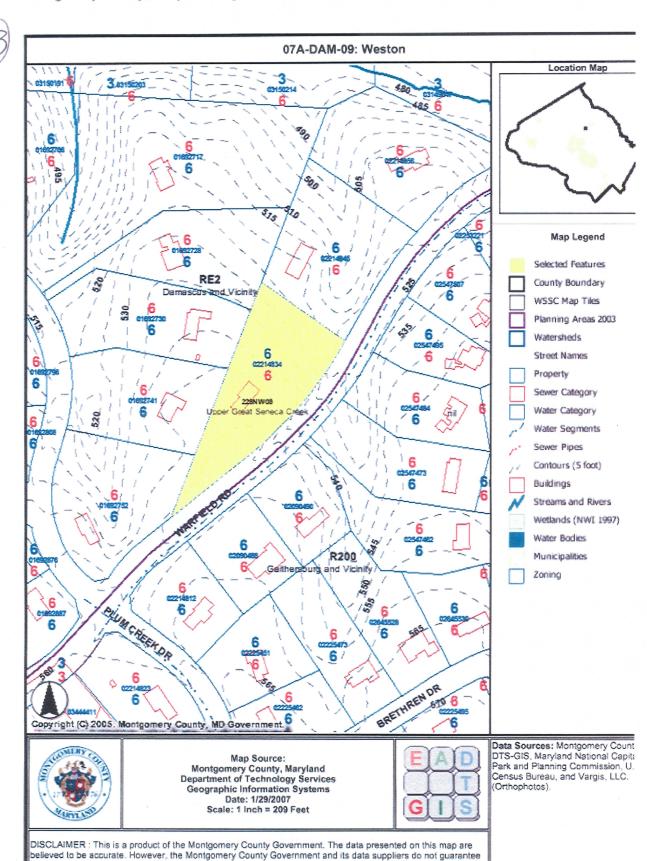

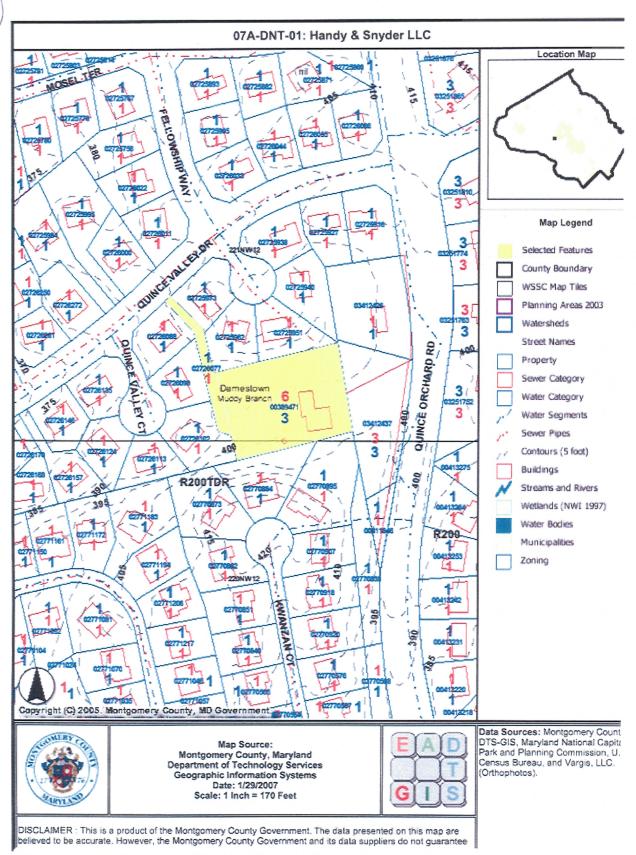

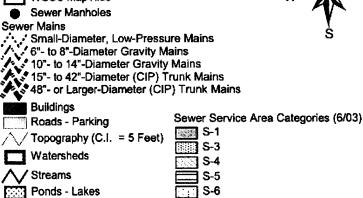

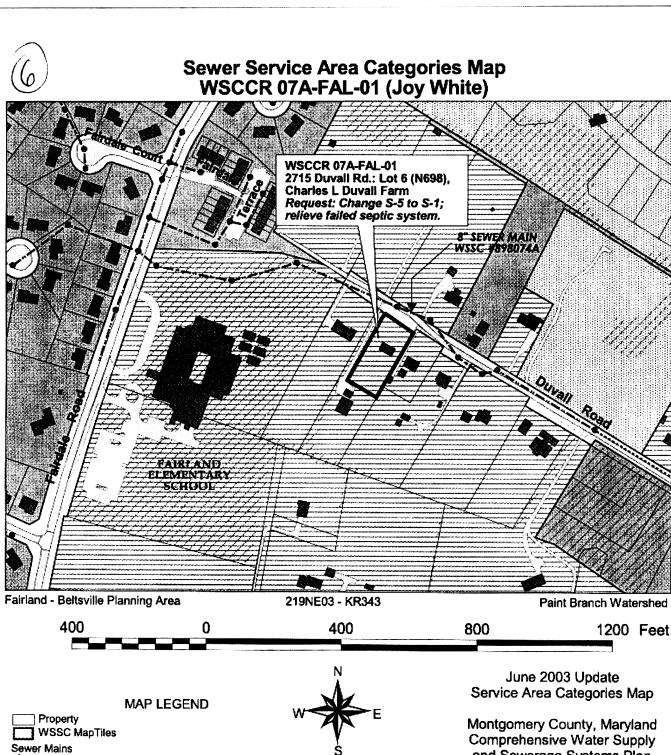

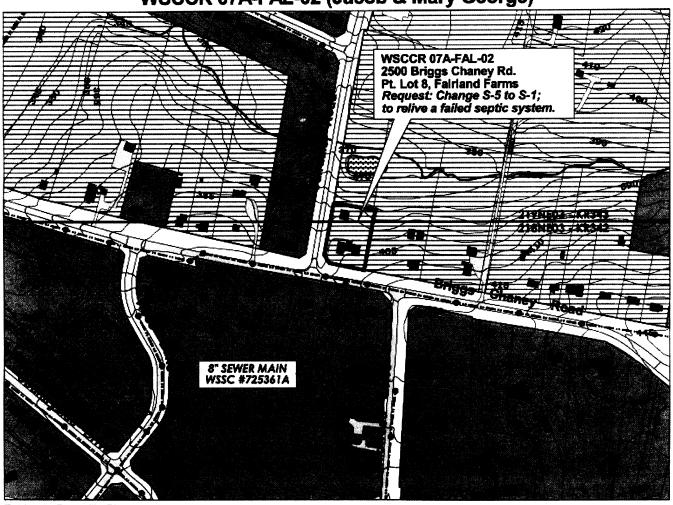

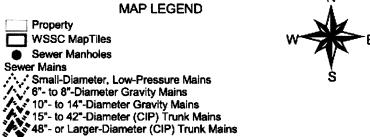
Sewer Service Area Categories Map WSCCR 07A-FAL-02 (Jacob & Mary George)
