APPLICATION

DESCRIPTION: Modify street tree locations and lamp fixtures, clarify natural trail detail,

modify width of sidewalk near play boulders, and add stream restoration project; located on MD 355 approximately 2,200 feet north of MD 121;

Clarksburg Master Plan.

APPLICANT: Miller & Smith at Woodcrest, LLC

EXECUTIVE

SUMMARY: The amendment seeks to modify street tree locations per DOT requirements


and change private lights to fixtures that are "Dark Sky" compliant. The trail leading from the site to the adjacent park will remain mulch and has been moved to avoid existing trees – this change needs to be clarified on the site plan. The sidewalk around the climbing boulders will be modified to a width of five feet. A stream restoration project has been added per the permits for

wetland impacts.

SITE DESCRIPTION

Vicinity

The subject site is located on MD 355 approximately 2,200 feet north of MD 121 and is adjacent to the Little Bennett Regional Park.

Site Analysis

The subject site is currently being improved per Site Plan 82005009A. There are no known rare, threatened, or endangered species on site. There are no known historic properties or features on site.

AMENDMENT DESCRIPTION

Previous Approvals

Preliminary Plan

This plan is subject to the conditions of Preliminary Plan 120040190, which was approved for 52 one-family detached units and 34 townhouse units inclusive of 11 MPDUs on 47 acres zoned R-200/RDT on November 9, 2004.

Site Plan

Site Plan 820040090 was approved for 52 one-family detached units and 34 townhouse units inclusive of 11 MPDUs on 47 acres zoned R-200/RDT on February 8, 2005. Site plan amendment 82004009A was approved on September 6, 2007 for a number of modifications primarily to stormwater management facilities, Department of Parks requests, Fire Marshall requests, and other design changes.

Conformance to Conditions of Approval

The proposed development must comply with the conditions of approval for the original Site Plan 820040090 as enumerated in the Planning Board Resolution dated February 8, 2005. There were no modifications or additions to the conditions by amendment 82004009A and are none herein.

Description of Amendment[s]

The Applicant requests the following modifications to the Site Plan:

- 1. Amend street tree locations per Department of Transportation inspection requirements;
- 2. Amend lighting fixtures in private open space to be more compatible with lead walk fixtures;
- 3. Clarify materials and location of natural trail to Little Bennett Regional Park;
- 4. Amend climbing boulder detail to change surrounding sidewalk to five feet; and,
- 5. Add a stream restoration project as required by permits for wetland impacts.

PUBLIC NOTICE

A notice regarding the subject amendment was sent to all parties of record by the Applicant on July 31, 2008. The notice gave interested parties 15 days to review and comment on the amended site plan per Montgomery County Zoning Ordinance Section 59-D-3.7. Staff received no inquiries regarding the proposed amendment.

STAFF RECOMMENDATION

The proposed modifications to the site plan will not alter the overall character or impact of the development with respect to the original findings of approval. Further, these modifications will not affect the compatibility of the development with respect to the surrounding neighborhood. Staff recommends approval of Site Plan Amendment and Draft Planning Board Resolution 82005009B.
