Staff Recommendation: Approval with Conditions

# Background:

On December 8, 2008, the Commission received a letter of support from Mr. Frank Stelling and Mr. Uriel Perlman requesting to name one of the Department's soccer fields at Aberdeen Local Park in North Potomac in honor of Mr. Jeff Kauffman, a local girl's club soccer coach. Mr. Kauffman left coaching after the 2006 season.

The letter of support (See Attachment #1) describes Mr. Kauffman's organized sports leadership in the community over the years working in the park as a soccer coach. Noted among Mr. Kauffman's' many civic and personal achievements is his recognition as a talented soccer coach winning many championships; earning the title of Eastern Region Youth Coach of the Year in 2004 as well as Classic Coach of the year 2003 for MSI and the 2003-2004 United States Eastern Region Youth Coach of the Year by the National Soccer Coaches Association of America (NSCAA).

While these attributes are notable, several community representatives are requesting this dedication primarily because of the many ways in which he touched and shaped the lives of the players he coached. Mr. Kauffman has also been recognized by the community because of his role as a president and leader within MSI Soccer over the course of the past 3 years. The nine (9) letters of support (See Attachments #1 - #9 are a reflection of the wide range of local community support for the subject request).

#### Commission History & Policy for Park & Park Facility Dedications:

On September 10, 1998, the Montgomery County Planning Board adopted a policy and guidelines for the renaming of parks, and park facilities. (See Attachment # 10) While the adopted policy and administrative guidelines address renaming parks and facilities, it does not address dedications.

However, in the past, the Commission has, in fact, dedicated several park facilities to individuals such as:

- o Wheaton Regional Park Frank Rubini Athletic Complex; and the
- o Long Branch Wayne Park John Durham Athletic Fields.

The Commission adopted new policies for park dedications (See Attachment #10), which allows the dedication of a person's name to a park facility provided the proposal complies with the generally stated guidelines of requiring the nominated individuals(s) to provide some significant, civic, historic, and/or cultural contribution to the lives of the citizens of Montgomery County, the State of Maryland, or the Nation.

#### Public Review and Comments:

On March 9, 2009 in the MCPB Agenda for 3/19/09, the Department announced the proposed dedication request to the public on for general public review and comments (See Attachment #11) No additional comments were submitted to staff. All comments received on the proposed request were in support of the ballfield renaming. (See Attachments #1 - #9).

#### Staff Recommendations:

Staff recommends the approval of the soccer field dedication naming for Jeff Kauffman in recognition for his many contributions to girls soccer in Montgomery County and for his strength and character in molding the lives of the many young women he coached for over twenty years.

Staff approval is subject to the following terms and conditions:

- 1. That the dedication be physically recognized in the form of a mounted plaque located immediately next to the soccer field indicating the field is dedicated to, and named after Jeff Kauffman for his many contributions for over 20 years to girls soccer;
- 2. That the cost for the dedication recognition plaque be borne by the proponents and/or supporters of the dedication and that all required funds must be received by the Commission prior to the installation of the plaque; and
- 3. That the cost to repair and/or replace any damage and/or vandalism that may occur to the plaque must be borne by the proposer for a period of at least the first 3 years (which will be included in the plaque installation budget) and that the Commission will not be obligated to replace the plaque, if vandalized or damaged after 5 years.

Dear Mr. Hanson,

We respectfully request the naming of the soccer field at Aberdeen Park, located in North Potomac, after our friend and colleague Jeff Kauffman.

Jeff coached our daughters from elementary school through high school. He has been a leader and youth coach in the Montgomery County soccer community for many years. His teams have won league championships, but more importantly, they have been awarded numerous sportsmanship awards during his years in coaching. In addition to his coaching, he has also been a long time volunteer to MSI and has served as president of the league since 2006. Jeff's attitude towards his players has always been respectful and he has constantly demanded that they be great sports as well as great players.

Jeff was awarded the 2003 Classic Coach of the Year for MSI and the 2003 and 2004 United States Eastern Region Youth Coach of the Year by the National Soccer Coaches Association of America (NSCAA). To be nominated as Coach of the Year, NSCAA requires that the individual:

- is dedicated to the total development of his or her soccer players;
- creates an environment conducive to learning and having fun;
- is a teacher of the game

Jeff personifies all three of these criteria. In addition, he always treated each player, as well as opposing players and coaches with respect and sportsmanship. Many of our daughters played for Jeff over the course of his many years in coaching. He treated each of our daughters fairly, with respect and made each of them feel special. He also taught them to be competitive and to put 100% effort in playing the game fairly and to play as a team.

Jeff left coaching after the 2006 season. However, he has continued to serve in many capacities with MSI; and, as stated above, has been the president of MSI for the past 3 years. In addition to his role as president, Jeff has spent considerable hours of his personal time chairing committees, creating tournament programs and other graphics for MSI and assisting with MSI service projects.

His dedication to his players and his service and work with the local soccer community has been an inspiration to all who have known him, served with him and been coached by him.

Since he left coaching, many of us who have been touched by Jeff's work have wanted to do something special to show him how much our local community cares about him and to thank him for his contributions to the game. We thought that naming the soccer field at Aberdeen Park would be a fitting tribute. He has spent many hours coaching his players at the park and it is located in our neighborhood.

We have discussed this idea with many individuals in the Quince Orchard area and in the soccer community. All are excited about the possibility of naming the Aberdeen Park soccer field after him. We look forward to hearing from the Commission.

Please add my name to the list of County residents lobbying for the Commission to rename Aberdeen Park in honor of Jeff Kauffman. I won't repeat what is contained in the attached letter although I completely agree that Jeff is the embodiment of leadership, sportsmanship and community service. I have known Jeff and his wife Roni for 20 years and I have served with Jeff on the Board of Directors of MSI Soccer for the past five years. Naming the Park in his honor would be a very generous gesture on the part of the Commission but one that he well deserves.

I do feel compelled to add a sad footnote to the letter you received. For the past two years, Jeff has been battling a very aggressive cancer. He discovered the cancer when he went to the ER with severe pain in his leg; it turned out that he had metastatic kidney cancer that had progressed to the point that it had essentially dissolved his femur. Jeff underwent surgery and chemotherapy at NIH/NCI and after some initial successes, he has recently been diagnosed with metastases to his lungs. He is currently under evaluation for a stem cell treatment at NIH. We all remain hopeful that Jeff will continue to win this battle notwithstanding the daunting nature of the challenge he faces.

Thank you for your attention to this. I hope that this can be accomplished and, if at all possible, in time for Jeff's birthday in March. I know the Commission has much more pressing business but I sincerely hope a way can be found to make this happen.

#### The Policy

Montgomery County parks and areas and facilities within parks are generally named for a geographic area or a natural historic feature, but, as appropriate, parks and areas and facilities within parks may be named to reflect local folk usage, or significant historic, material, or financial contributions to the Commission, or persons of historic or outstanding civic service. Markers may be placed in parks and on park facilities honoring or memorializing individuals and organizations.

Approved: September 10, 1998

#### **GUIDELINES RECOMMENDATION**

Guidelines for Naming or Renaming Parks
Guidelines for Naming or Renaming Areas in Parks and Facilities in Parks
Guidelines for Memorials and Dedications in Parks and on Park Structures and Facilities

1. Requests for naming or renaming parks, and naming or renaming areas and facilities in parks, and establishing memorials in parks and on park structures and facilities, shall be reviewed by staff of the Department of Park and Planning. A report with recommendations shall be presented to the Planning Board within sixty (60) days of the initial request.

#### Guidelines Recommendation, page 2

- 2. Staff recommendations regarding the naming or renaming of parks, and areas and facilities in parks, shall be guided by the following considerations:
  - A. Recognized geographic names
  - B. Natural historic features
  - C. Folk usage
  - D. Significant historic contributions
  - E. Significant material contributions
  - F. Significant financial contributions (at least 25 percent of the total project cost)
  - G. Persons of historic service to the County or Commission
  - H. Persons of outstanding civic service to the County or Commission
- 3. Memorials or dedications may consist of (a) structures, such as buildings, or facilities, such as athletic fields, that may be named in memory of individuals and organizations as complete entities, or (b) memorial or dedication plaques or signs on or inside structures and facilities.
- 4. The name of a memorial or dedication must be approved by the Planning Board.
- 5. Upon approval by the Planning Board, letters of agreement shall be exchanged between the Commission (or the Montgomery County Parks Foundation, Inc.) and the person(s) or organization(s) requesting a memorial or dedication, authorizing and designating responsibility for the planning, design, construction and funding of the memorial or dedication.
- 6. Staff recommendations to the Planning Board regarding the establishment of memorials and dedications in parks and on park structures and facilities shall be guided by the following considerations:
  - A. The location, design, and configuration of a proposed memorial or dedication shall be in keeping with the park purpose and usage and shall not interfere with public use of the park or park facility.
  - B. Department of Park and Planning staff shall participate in the planning, design, and construction of a memorial or dedication, if relevant.
  - C. All costs associated with a proposed memorial or dedication, including planning, design, construction, utilities, and maintenance (if significant) shall be the sole responsibility of the person(s) or organization(s) requesting the memorial or dedication. Full funding for the memorial or dedication shall be paid to the Commission or to the Montgomery County Parks Foundation, Inc., prior to the start of planning, design, and construction.
  - E. In all cases involving memorials or dedications, only the memorial or dedication itself may be named. The park name shall remain unchanged.

Mr. Kauffman's coaching won his soccer teams many championships earning him the title of Eastern Region Youth Coach of the Year in 2004, as well as Classic Coach of the Year in 2003 for MSI, and the 2003-2004 United States Eastern Region Youth Coach of the Year by the National Soccer Coaches Association of America (NSCAA). Most notable among Mr. Kauffman's greatest achievements in girls' soccer are the many ways he helped shape the lives of the young women he coached.
