and FY11-16 Capital Improvements Program (CIP)

STAFF RECOMMENDATION:

Approval to transmit comments to the Montgomery

County Council.

Staff recommends the following comments to the County Council. Further detail of these projects and priorities are shown later in this memorandum:

- 1. To assure continued protection for the Agricultural Reserve, provide a capital project for the Building Lot Termination (BLT) easement program in the same manner as the Agricultural Land Preservation easement program.
- 2. Support priority funding for the Silver Spring Library as a proposed Leadership in Energy and Environmental Design (LEED) gold certified public building that will serve as a catalyst for continued public and private sector investment.
- 3. Maintain funding for planning and design to relocate multiple County Service Park uses and the Public Service Training Academy (PSTA) to implement the Shady Grove Sector Plan and the forthcoming Gaithersburg West Master Plan, including the M-NCPPC and Montgomery County Public Schools (MCPS) Food Distribution facilities.
- 4. Endorse planning and design funding of the proposed Dennis Avenue Health Center which will provide vital health services to a transit-dependent community in the diverse Forest Glen/Wheaton area.
- 5. Proceed with construction of the Bioscience Education Center on the campus of Montgomery College-Germantown including a section of Observation Drive. Siting for the roadway segment should adhere to recommendations of the County Council to keep forest removal to less than four acres of the large forest stand recommended in the Germantown Employment Area Sector Plan.

BACKGROUND

The purpose of this report is to provide comments to the County Council on the FY11-16 Capital Improvements Program released by the County Executive on January 15, 2010. This six-year CIP (FY11-16) totals \$3.9 billion with an overall spending increase of 4.5 percent over the previous CIP to accomplish priorities in school construction, public safety, affordable housing, infrastructure, economic development and environmental protection. The Executive noted that despite the difficult economic times, funding infrastructure now with low construction prices can save the County millions of dollars in future construction costs. The County Executive's proposed CIP closely mirrors the budget submitted by Montgomery County Public Schools (MCPS).

The role of the Planning Board is to provide comments on recommended projects and also to highlight additional projects necessary to implement Master Plan recommendations, staging requirements or projects which resolve constraints identified by the Annual Growth Policy. A summary of the CIP planning process is included as Attachment A.

As the current Growth Policy was developed, staff developed a "ranking" system to be used to objectively evaluate all CIP projects countywide. This information was included as Appendix G of the Growth Policy studies (http://www.montgomeryplanning.org/research/growth-policy/growth-policy09/documents/AppendicesGHI.pdf). The County Executive's response to Growth Policy Appendix G is included as Attachment B. Later in this report, staff will provide a proposed "ranking" of FY11-16 projects.

In scoring the school facilities for priority within the CIP, staff considered the recent amendments to the current CIP. These CIP amendments removed from moratorium three school clusters: Bethesda-Chevy Chase, Seneca Valley, and Northwest. Approval for residential development within these three clusters will require that a school facility payment be made at the time of building permit.

The CIP discussion between staff and the Planning Board will consist of three parts:

- Recommended transportation project additions to the FY11-16 CIP provided in a separate memo from Larry Cole and Justin Clark
- 2. <u>Overview of General Government (non-transportation) projects</u> included in the CIP plus any additions or noted projects
- 3. Priority ranking of new and recommended FY11-16 CIP projects

OVERVIEW OF GENERAL GOVERNMENT PROJECTS

South Central Transit Corridor

This area covers the geographic areas of Bethesda, Chevy Chase, North Bethesda, White Flint, Silver Spring, Long Branch, and Takoma/Langley Crossroads.

Representative projects for this area include:

- BRAC bicycle and pedestrian facilities
- Silver Spring Transit Center
- Silver Spring Library
- Additions to B-CC cluster schools including Bethesda Elementary School, Somerset Elementary School, and North Chevy Chase Elementary School
- Sidewalks along Dale Drive from MD97 to US29
- Sidewalks along Dale Drive from Mansfield Road to Hartford Avenue

The Base Realignment and Closure (BRAC) Act will affect the National Naval Medical Center in Bethesda. The priority CIP project is for planning, design, and construction of a bikeway network and addition of pedestrian facilities surrounding the National Naval Medical Center (NNMC) due to Base Realignment and Closure (BRAC). It will include additional safe pedestrian/bicycle facilities, such as master planned bike paths, sidewalks, signing, pavement markings, lighting, bus stop pads, landscaping and other issues to ensure pedestrian and bicycle safety.

The Dale Drive Sidewalk (from Mansfield Road to Hartford Avenue) project will provide a connection to existing sidewalks along Dale Drive between Mansfield Road and Hartford Avenue. It will provide safe access for pedestrians to Sligo Creek Elementary and Silver Spring International Middle Schools, to Sligo Creek Park and to downtown Silver Spring and nearby public transportation.

The Project Description Form (PDF) for several projects within the Long Branch Town Center Redevelopment Area (#157700 and #760600) should reflect that coordination is needed with the Long Branch Sector Plan currently underway.

The existing Silver Spring Library is the oldest in the Montgomery County Public Libraries system. It is the second smallest community library and has the smallest collection of non-periodical materials of any community library. Silver Spring is growing in terms of the size and diversity of its residential population, and is experiencing significant expansion of its business community, all of which place greater demands on library services.

The proposed Silver Spring library represents a shift in the type of library within Montgomery County as it is a component of a much larger public private partnership. It moves from a suburban to an urban typology and concentrates a mixture of uses on a single site served by bus and light rail transit. With a proposed LEED gold certification, it will be one of the most environmentally sustainable buildings in the County. The County Executive's proposed CIP states "based on Council action, it was determined that a pedestrian bridge over Wayne Avenue would not be included **at this time.**" (emphasis added)

North Central Transit Corridor

This area covers the geographic areas of Shady Grove, Gaithersburg Vicinity, Gaithersburg West, Germantown, and Clarksburg.

Representative projects for this area include:

- Shady Grove Metro Station Access bike path
- Equipment and Maintenance Operations Center (EMOC) relocation to the Casey
 6 and 7 properties
- Travilah Fire Station near the Life Sciences Center
- Public Service Training Academy (PSTA) relocation to the Webb Tract
- Department of Corrections staff training facility
- Clarksburg Library
- Clarksburg Cluster Elementary School (Clarksburg Village site #1)
- Bioscience Education Center at Montgomery College including Observation Drive
- Renovations to Plum Gar Neighborhood Recreation Center
- Elementary school improvements in Seneca Valley and Northwest clusters, Germantown
- Montgomery County Airpark

Planning has begun for relocating County Service Park uses including the MCPS and M-NCPPC maintenance facilities (project #361109). These actions include relocating the EMOC facility, Department of Liquor Control warehouse, MCPS Food Distribution and other facilities in order to implement the Shady Grove Sector Plan. Transportation Planning staff highlighted the need for constructing the Amity Drive extension as part of the EMOC project. A site to accommodate MCPS bus maintenance and parking has not been identified.

Projects within the Gaithersburg West Master Plan area include relocating the PSTA and constructing the Travilah Fire Station.

A number of Clarksburg projects are recommended by the County Executive including planning and design for the Clarksburg Library within the Clarksburg Town Center; school improvements for elementary, middle and high schools; and a staff training facility for the Department of Corrections. The recommended CIP contains the North County Depot project (#500522) for a site in Ten Mile Creek in Clarksburg. This site should only be used as a last resort if no other site can be found. An expanded site selection process is underway to locate a site outside of the Ten Mile Creek watershed.

Several projects in the Germantown Employment Area Sector Plan are noteworthy: construction of Observation Drive on the Montgomery College-Germantown campus to serve the Bioscience Education Center (#056603); renovations to the Plum Gar Neighborhood Recreation Center; and elementary school improvements in the Seneca Valley and Northwest clusters.

East Transit Corridor

This area covers the geographic areas of Wheaton, Forest Glen, Four Corners, Fairland, Cloverly, Aspen Hill, Kemp Mill, Olney, and Upper Rock Creek.

Priority projects for this area include:

- Dennis Avenue Health Center
- 3rd District Police Station
- Animal Shelter replacement
- Glenmont Fire Station #18 replacement
- Kensington (Aspen Hill) Fire Station #25 addition
- Olney Library renovations

The Dennis Avenue Health Center project provides planning and design funds to replace the existing center in the Forest Glen area. The new center will alleviate significant structural and operational deficiencies in the existing facility, which provides vital public health services to a diverse downcounty population.

Considerable community concerns have been raised about the 3rd District Police Station project. Local residents can support a standalone police station, but have concerns about a new police station combined with multifamily housing on the same property, a combination the executive branch has broached. This project's complete parameters should be discussed fully with affected local residents as this proposal moves forward.

The Animal Shelter project at Laytonia Recreational Park was initiated after completion of the 2004 Upper Rock Creek Area Master Plan, which supports planning and development of an active recreation park at this location. The Parks Department is working closely with executive branch agencies to integrate the proposed shelter into its planning for Laytonia Recreational Park. Mandatory Referral review will be an important component of this project's development.

Potomac/Rural

This area covers the geographic area of the Agricultural, Rural and Open Space Master Plan, Boyds, Potomac, Darnestown, and Damascus.

Representative projects in this area include:

- Agricultural Land Preservation Easements
- Cabin John Fire Station #30
- Scotland Neighborhood Recreation Center
- Darnestown Elementary School addition
- Seven Locks Elementary School

The CIP provides funding for Agricultural Land Preservation Easements as an economic development tool. A second significant agricultural preservation easement, Building Lot Termination (BLT), is not addressed in the CIP. The BLT easement is another type of easement that may be purchased by the County under Chapter 2B. Similar to other

agricultural easement programs of the County, the primary purpose of the BLT Easement is to preserve agricultural land by reducing the fragmentation of farmland resulting from residential development. A BLT Easement will restrict residential, commercial, industrial and other non-agricultural uses. A key feature of the BLT Easement is an enhanced level of compensation to a landowner who can demonstrate that their land is capable of residential development and agrees, as part of the BLT Easement, to forego residential development and also agrees to restrict other types of development on their land. Currently, the TMX zone provides for BLTs when property is developed under the optional method; the proposed LSC and CR zones would also provide for BLTs.

PRIORITY RANKING OF NEW AND RECOMMENDED FY11-16 CIP PROJECTS

Staff evaluated the Executive's recommended CIP projects using a scoring methodology developed in the 2009 Growth Policy.

The ranking system in the 2009 Growth Policy emphasizes:

- Sustainability in terms of cost, environmental impact and social equity
 - Giving higher priority to Metro station areas, other urban areas, and State Priority Funding Areas
 - Leveraged funds where the County can maximize its investment by using developer, State and/or Federal funds

Master Plan or Sector Plan goals and objectives

- o Where master plans have staging requirements
- Where school capacity issues are identified
- o Constrained Long Range Plan (CLRP) for transportation

Connectivity

- Meeting transportation serviceability goals contained in the Highway Mobility Report, in traffic forecasts and for emergency preparedness
- o Coordinating public facilities with private development
- Linking jobs to housing
- o Linking neighborhoods to services

Design excellence

- Ensuring safety
- o Giving higher priority to projects that serve more than one purpose
- o Promoting neighborhood conservation and enhancing community identity
- o Restoring or minimizing impacts to natural resources
- Promoting, either directly or indirectly, the preservation of historic resources

Diversity

- Promoting travel other than SOV; pedestrian accommodation; bikeways; transit; multi-modal Quality of Service
- o Promoting community facilities that serve all types of neighborhoods and interests

The following projects are highly ranked by this scoring system (Attachment C):

- 1. Georgia Avenue Busway
- 2. Silver Spring Library
- 3. BRAC pedestrian and bike improvements
- 4. Metropolitan Branch Trail
- 5. Viers Mill Busway
- 6. Glenmont Metro bikeway
- 7. Clarksburg Transit Center (candidate for facility planning)
- 8. University Boulevard Bus Rapid Transit (will be included in facility planning after FY16)
- 9. Montrose Parkway East
- 10. 2nd District Police Station relocation (developed selected for land swap)
- 11. Capital Crescent Trail
- 12. Clarksburg Library
- 13. Randolph Road bus improvements (candidate for facility planning)
- 14. Bioscience Education Center at Montgomery College-Germantown including construction of Observation Drive
- 15. Cedar Lane Bridge over Rock Creek (new project)
- 16. Westbrook Elementary School in B-CC cluster
- 17. Bethesda Elementary School in the B-CC cluster
- 18. Flower Avenue S/W from Piney Branch Parkway to Carroll Avenue
- 19. Georgia Avenue/Forest Glen Road pedestrian improvements
- 20. 3rd District Police Station in Colesville/White Oak

(Italic/bold projects are new projects in the FY11-16 CIP)

The priority projects from the 2009 Growth Policy included seven non-transportation projects including three schools in the B-CC cluster. The new ranking done by staff to prioritize the projects in the Executive's proposed projects yielded six non-transportation projects including the 2nd District Police Station serving the Bethesda CBD and the 3rd District Police Station in Colesville-White Oak; the Silver Spring and Clarksburg Libraries; and two schools in the B-CC cluster. The Silver Spring Library, scored second highest by staff. A replacement bridge project over Rock Creek which was added to the CIP this year was ranked 15th.

CONCLUSION

Current economic conditions have sharply affected the County's ability to fund new initiatives and may delay needed projects in all parts of the County. The County Executive recommended a nearly identical set of school projects with special attention given to critically needed replacement schools and also areas with existing or foreseen school capacity issues.

The M-NCPPC staff will continue to monitor CIP projects as they are authorized through site selection, facility planning and Mandatory Referral reviews. Several Project Description Forms (PDFs) should add M-NCPPC to the Coordination list:

- 1. Good Hope Neighborhood Recreation Center
- 2. Ross Boddy Neighborhood Recreation Center
- 3. Needwood Golf Course
- 4. Northwest Golf Course
- 5. Bioscience Education Center and construction of Observation Drive

ATTACHMENT A

CIP PLANNING PROCESS

ACTIONS BEFORE THE START OF THE FORMAL CIP CYCLE

The CIP is part of an ongoing planning, programming, and implementation cycle. The CIP process provides a significant means of implementing the recommendations in a master plan.

Approved and Adopted Master Plans: Each master plan lists the CIP projects required for implementation. The master plan describes each proposed CIP project, the location, the responsible agency, and the implementation time table. Recent master plans contain separate implementation plans (e.g. Shady Grove Sector Plan, the East Silver Spring Master Plan, and the North and West Silver Spring Master Plan). These master plans also instituted advisory groups to assist in implementation.

CIP Forums by Citizens' Advisory Boards: The M-NCPPC and the Executive Citizens' Advisory Boards hold forums to discuss the proposed items to be included in the CIP. At these forums, the Montgomery County agencies and the M-NCPPC explain projects and priorities, and ask the public for their priorities and comments. The Citizens' Advisory Boards review each project and send recommendations to the appropriate agencies identifying the priorities.

M-NCPPC Comments on the CIP Relayed to the Executive: After the CIP forums are completed, the staff of the M-NCPPC prepare recommendations based on the master plan guidelines and the input during the citizen forums. In July, before the Executive CIP cycle, the Planning Board recommends priorities to the Executive based on the staff report. The Planning Board recommendations are intended to implement master plan recommendations, and identify the facilities needed to implement recent regulatory planning efforts.

ACTIONS DURING THE FORMAL CIP CYCLE

Executive Recommended CIP – By Charter, the County Executive develops and recommends budget proposals and the Council authorizes expenditures and sets property taxes. The six-year CIP period starts July 1 and ends June 30 the next year. The CIP is published by January 15. Governmental agencies and County departments submit CIP requests to the Office of Management and Budget (OMB). Based on the recommendations from the agencies and the M-NCPPC comments, the Executive reviews such requests between September and December, and submits the Recommended Executive Six-Year CIP by January 15 of even-numbered years.

CIP Review by the Planning Board: The Planning Board reviews the Executive Recommended Six-Year CIP in January. The Planning Board sends official comments to the Council President by early February.

CIP Approval by the County Council: The Council holds public hearings on the County Executive Recommended CIP no earlier than 21 days after their receipt. Following public notice and input, the Council begins its CIP review, and a designated Council committee reviews each CIP category area. In April and May, the full Council reviews the Committee recommendations, and takes final action on each project of the CIP in even-numbered years. The County Council approves and appropriates funds for the CIP by June 1, and sets the property tax levies to finance the budget by June 30.

ACTIONS DURING CIP IMPLEMENTATION

Public Sector: Montgomery County submits Mandatory Referrals to the Planning Board for proposed County projects for review and comment. Each agency provides public notice of these projects and provides opportunities for public comment. The Planning Board reviews Mandatory Referral projects including conformance with the appropriate master plan, and the CIP. The Planning Board's comments are advisory, and the statute permits the applicant to overrule the Planning Board's action and proceed.


Private Sector: A substantial number of projects are built or financed by the private sector. Since the needs for many CIP facilities are generated by proposed private development projects, agreements are often negotiated with the proposed developers to build or provide funds for a capital facility as a condition of approval of a rezoning, project plan, subdivision, site plan or special exception. In some cases, CIP projects are financed, or partially financed by a number of developers of private projects benefitting from the project(s).

To help track CIP transportation projects financed by the private sector, every two years the Planning Department submits a status report on transportation projects constructed by the private sector.

Master Plan Status Report: The M-NCPPC prepares a Master Plan Status Report to track CIP projects recommended by each Master Plan. This Report tracks every Planning Area and identifies the status of recommended CIP projects. This Report is intended to aid officials to set funding priorities.

Project: Traffic Signal System Modernization

Status: Phase I - Planning and Systems Engineering, was completed in FY08. Phase II — Deployment commenced in FY09. Phase II will be organized into II-A and II-B to accelerate the project based on the November 2009 catastrophic failure of the existing system. Phase II-A will encompass critical work that is necessary to deactivate the existing signal system and will be completed by the end of FY12. Phase II-B will include all other work that is not critical to replacement of the existing system, and that work will commence in FY13. The project schedule for Phase II-B has not been finalized and is dependent on the availability of State aid.

Project: Capacity and Modernization Projects

Status: The Board of Education's (BOE) Requested FY11–16 CIP includes funding to address critical capacity needs systemwide, to continue the modernization program to address our aging schools, and to provide additional funding to many countywide systemic projects to maintain our capital investment.

The BOE's FY 11–16 CIP will continue to address capacity needs, especially at the elementary school level where enrollment is on the rise. The following are the capacity projects in the BOE's request: Bradley Hills, Darnestown, Georgian Forest, Somerset, Viers Mill, Waters Landing, Westbrook, and Wyngate elementary schools, and Clarksburg High School. Also, the Requested FY11–16 CIP includes funding for one new elementary school and one new middle school to address the overutilization in Clarksburg Cluster schools.

The Requested FY11 Capital Budget and the FY11–16 CIP will maintain the completion dates for all individual school projects, modernizations, and systemic countywide projects as approved in the adopted CIP. The Requested FY11–16 CIP includes funding for eight new elementary school additions and one new high school addition; funding for a new elementary school and middle school; increases to various countywide systemic projects; funding in the Facility Planning project to conduct the next round of Facilities Assessment with Criteria and Testing (FACT) assessments for modernizations; and funding to reopen two facilities for use as holding schools for school modernizations.

The Requested FY11–16 CIP includes funding to provide additional capacity for four clusters—Bethesda-Chevy Chase, Clarksburg, Northwest, and Seneca Valley—that are currently in residential development moratorium, according to Montgomery County's Growth Policy school test. If these capacity projects are approved as requested, the four clusters will fall below the 120 percent threshold and, therefore, be out of residential moratorium when the next school test is adopted in June 2010.

The County Executive recommended 99.4% of the BOE's request. The Executive will rely on the Board to determine how to revise the project schedules to conform to the recommended funding levels.
