

Description

Location: In the northeast quadrant of the intersection of Woodmont Avenue and Bethesda Avenue Zone: CBD-2 Master Plan: Bethesda CBD Sector Plan Property size: 5.8 acres Application to extend the review period for a project plan for up to 41 days, from March 2, 2012 to April 12, 2012 Applicant: Street Retail; JBG Filing Date: October 24, 2011



Summary

Staff Recommendation: Approval of the extension.

Section D-2.2 of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 90 days after the filing of a project plan. The Planning Board may, however, extend this period. Several complex issues affecting the project remain to be resolved, including issues relating to the proposed on-street (i.e., non-tunnel) alignment of the Capital Crescent Trail, non-standard amenities in the public right-of-way of Bethesda Avenue, and provision of adequate public use space. The applicant has requested, in a letter dated February 9, 2012, that the review period for the project plan be extended for up to 41 days, from March 2, 2012, until no later than April 12, 2012, to allow the applicant to address these issues. In a previous letter dated December 29, 2011, the applicant requested an extension of the review period, from January 26, 2012, until March 2, 2012. The Board granted this extension on January 26, 2012.

Staff recommends APPROVAL of the extension request.
