

#### Summary

- In accordance with section 59-D-2.2 of the Montgomery County Zoning Ordinance in regards to the Project Plan requirements, the Planning Board shall hold a public hearing no later than 90 days after the filing of a project plan (i.e. August 16, 2012). However; the Planning Board may extend this period if requested by interested parties, provided that such extension shall be found to be reasonable and does not constitute prejudice or undue hardship to any interested party.
- The Applicant has submitted a letter of request (dated July 9, 2012) to allow the extension of the review period due to the conflict of the target date being scheduled during the August break, and to resolve outstanding matters related to the plan (see the attached letter).
- Staff finds that the 90-day extension of the review period will not constitute prejudice or undue hardship on any interested party, and recommends approval of the request to extend the review period for this project plan to no later than November 8, 2012.
