

Recommendation

- In accordance with section 59-D-2.2 of the Montgomery County Zoning Ordinance in regards to the Project Plan requirements, the Planning Board shall hold a public hearing no later than 90 days after the filing of a project plan (i.e. August 16, 2012). However; the Planning Board may extend this period if requested by interested parties, provided that such extension shall be found to be reasonable and does not constitute prejudice or undue hardship to any interested party.
- The Applicant has submitted a letter of request (dated October 1, 2012) to allow the extension of the review period due to address various issues specifically related to the Preliminary Forest Conservation Plans, transportation, proposed density, and the design of the overall layout (see the attached letter).
- Staff believes that the 75-day extension of the review period will not constitute prejudice or undue hardship on any interested party, and recommends approval of the request to extend the review period for this Project Plan to no later than January 25, 2013.

On behalf of North Village—270 Limited Partnership, the Applicant in the referenced Project Plan, and pursuant to Montgomery County Zoning Ordinance Section 59-D-2.2, we request an additional extension of time of approximately 75 days for the Planning Board to hold a public hearing on the Project Plan.
