WHATEVER ARE YOU THINKING??

To put a major commercial development at the northernmost reach of the Rt. 355, two-lane access road into Clarksburg, MD that is already at saturation? I spent two years lobbying for a simple passby lane on Rt. 355 at the West Old Baltimore Rd. left turn site just to keep the traffic from backing up to south of Rt. 27 during evening rush hour. Now it only backs up past Brink Rd. to the recreational area, and you are considering allowing a new major commercial draw that will multiply traffic on Rt. 355 beyond tolerance? Why would ANYONE consider allowing something so absurd before the necessary infrastructure is in place, if at all? And to make the proposal even more ludicrous, this would put it at the very exit at I-270 where that interstate already reduces northbound from three lanes (four if you include the merge lane from Rt. 121) to just two, a veritable nightmare for evening rush hour traffic. Yeah, let's make that even worse by throwing in some outlet mall traffic! How brilliant!

Why?

Oh! Wait! This is Montgomery County, MD, the county that never met a source of new tax revenue it didn't love (to wit, the only county in the United States that's in the beer, wine, and liquor business, and then undercuts its commercial customers' beer and wine prices in its own county stores—what a great business model that is, but, of course, ANYTHING for more revenue). And how much more tax revenue will this mall bring in? And potentially the one across the interstate as well? For just how much new tax revenue is the county willing to prostitute the promised, sensible development of Clarksburg?

To hell with the agriculture reserve, with five-acre minimum residential zoning, with preservation of ecologically-sensitive headwaters, with the long-standing Clarksburg Master Plan and its carefullylaid-out development process for Clarksburg Town Center (which has still not been fulfilled), with the impact on Clarksburg residents who believed that Master Plan and moved to Clarksburg fully expecting the promises of a more pastoral and walker-friendly way of life (what dupes!).

Yeah, to hell with all of that—THIS, AFTER ALL, MEANS MORE TAX MONEY TO SPEND!

Rest assured on this point, though: I will be an active lobbyist and campaign agent to remove anyone from county government, up to and including the county executive, who has a hand in approving this proposal to go forward.

I am writing to express my concern regarding the recommendations about Stage 4 of the Master Plan for development in Clarksburg. Here are the motivating forces that compelled me to write this letter tonight.

1) As I was driving home on Monday, a kid, probably about 14 years old, was walking on the side of 355. He was on the shoulder of the road, probably heading home from a friend's house. It was not dark out, yet he was almost struck by a car, not because he was doing anything wrong but because the road is not safe! The road does not have adequate shoulder in many places. Where are our priorities??? More traffic congestion and pedestrian traffic in the community, when the basic infrastructure of existing roads has not been addressed is bad public policy. Please support a walkable Town Center.

2) Have you seen the 4-color glossy advertisement put out by Pulte Homes? It is horrifically misleading, one has to search for the author, and they are asking for community members to sign the card and send it in to "Preserve Clarksburg's Future"...Ridiculous. Something is REALLY WRONG if a developer has to initiate grassroots lobbying efforts and hire an ad

firm. Please reject this proposal.

3) The proposed outlet Mall on the Miles Copola 355 is going to add to the already bad traffic on 355. Please reject this proposal. During rush hour, it takes me longer to drive between Germantown and my home, than it does for me to drive from Baltimore City to the County region. I am not alone when I say that I no longer shop in Montgomery County because of the traffic and hassles of parking ect. The truth is I often head West and shop/support businesses in Frederick.

4) Ten Mile Creek should be protected from all development and be part of the Ag Reserve. I would prefer to take my kid looking for salamanders than shop for an expensive purse or the "upscale shopping and dining experience" so they claim. I am mortified that I have to even write about this. We have an opportunity to protect a beautiful stream that feeds the Seneca Reservoir and we should take it, for generations to come. Upscale shopping can and should occur elsewhere.
