As you know, the County is in the process of Design Development for a major community amenity in Wheaton. The replacement of the existing Library and Neighborhood Recreation Center with the Wheaton Library, Community Recreation Center, and Gilchrist Center for Cultural Diversity will form a significant public anchor at the northern edge of the downtown and serve as an iconic gateway to a revitalized Wheaton proper. The County is currently in negotiations with the Commission to complete the acquisition of the Parks parcel where the Recreation Center now sits.

Recently the Historic Preservation staff recommended, and the Historic Preservation Commission (HPC) approved, a resolution to designate the "Wheaton Youth Center," as it had originally been named when built, as an historic structure. The HPC added a caveat to their motion that the designation should not impinge upon the design and development of the new facilities. Mr. Kirwan, HPC Chair, in his letter to the Executive and County Council President, indicated that the HPC encouraged the redevelopment with the application of "high quality, thoughtful design" to accomplish a "sensitively and compatibly" designed integration along with providing the "much needed facility and community service improvements."

The Countywide Recreation Advisory Board would encourage the Planning Board to consider the following items when deliberating over the HPC recommendation:

There is very little disagreement over the current condition of the Recreation Center. It is old, worn out, and well beyond the potential usable life of its structure and systems.

The current spaces, designed to be a "teen club house," no longer perform that function. Today and tomorrow's programming/services/activities must serve a very different population and demographic with very different needs as compared to the original building. The integration of the Community Recreation amenities with the Library and Cultural Diversity Center will provide an unparalleled opportunity to deliver the widest possible range of service to the Wheaton Community.

The individuals who spoke in favor of the designation at the HPC hearing related memories of their participation in activities at the location and not remembrances of the structure. The activities that were of major importance were produced and managed by Montgomery County Recreation, which will continue to be the case in the new building. New memories for current and future generations will continue to build the layers of history so important to the full sense of community in its broadest definition.

The project could be viewed as one that is transitional in nature and can bring forward important components of Wheaton's, and the County's, history through the development of these new facilities. By utilizing the criteria of the National Park Service's Heritage Documentation Programs, the existing structures and landscape can be documented in extreme detail. One advantage in this is that we have all of the original construction documents, the Park Department's renovation documents, and the added bonus of having the same Project Manager for this development, as for the renovations.

In addition, we believe the County is committed to honoring the former building and more importantly its programs with significant interpretive displays and activities in the new facility. Moreover, it is our understanding that the design team has indicated that there are a substantial number of architectural elements from the existing building that can be utilized in the new development emphasizing Mr. Kirwan's sensitive and compatible design integration concept.

Lastly, we are concerned that the absolute and complete retention of the entire existing Recreation Center structure on the site will have a massive impact on the design integrity and cost of this project. This impact could be substantial enough to cause a delay and, in the worst case, postponement or deletion of the project from the Capital Improvements Program for at least the foreseeable future. No one is well served by the loss of this project.

The Countywide Recreation Advisory Board recommends that the Planning Board give consideration to these issues as it deliberates its recommendation to the County Council and that we find some appropriate method to honor and reflect the past history of Wheaton while celebrating and planning for its bright future.

I want to thank the Board for its time and consideration of this item. If we can be of assistance with any questions or additional information, please do not hesitate to contact me.

The Wheaton Urban District Advisory Committee (WUDAC) consists of a representative cross-section of the Wheaton community, including residents and homeowners, small businesses, the Wheaton-Kensington Chamber of Commerce, and large businesses. On behalf of WUDAC, I want to express our appreciation to you and the Planning Board for extending the time frame for considering an amendment to the Master Plan for Historic Preservation of the Wheaton Youth Center (31/48), located at 11711 Georgia Avenue in Wheaton.

WUDAC is pleased to see that the Board has provided for a second hearing and postponed the work session originally planned for October 17, 2013. Recognition and preservation of our historic structures is extremely important to the future of our communities, and the County's Historic Preservation Ordinance, Chapter 24A, provides powerful protection for resources added to the Master Plan. However, such designations do not occur in a vacuum, which is why it is critical that the process move forward with full, thorough, and informed public participation. This is particularly important when the location under consideration by the Historic Preservation staff, at the direction of the Historic Preservation Commission, does not originate from parties in the community where the resource is located.

At WUDAC's monthly meeting held on October 6th, the committee discussed the proposed historic designation of the Wheaton Youth Center and its potential impact on plans for a new, updated recreational facility and library for the greater Wheaton area. WUDAC Members stated their desire to work with the Planning Board to better understand the potential impact on the recreation center and library project cost and timeline that accompany the historic designation of the existing structure. While individual WUDAC Members informally expressed opinions on the designation process and recommendations, as a group we concluded that WUDAC had neither sufficient time nor information to formally take a position on the project. In light of that conclusion, we voted to request an

extension of the comment period so that we, and the people of Wheaton affected by this project, could provide better-informed, definitive input into the amendment process.

Specifically, we request that the second hearing not be held until after November 12, 2013 in order to allow WUDAC the time to formally adopt a position on the proposed amendment and historic designation of the existing Wheaton Youth Center. WUDAC additionally requests the November hearing to occur during the evening hours to better accommodate the majority of the community who want to participate in the discussion and process. An open, transparent, and convenient process is paramount to ensure the public is well informed and understands what is at stake regarding the future of the recreational center and its redevelopment with the library.

Thank you in advance for a serious and thorough consideration of WUDAC's request.

am a residents' representative to the Wheaton Urban Development Advisory Committee (WUDAC) and was unable to provide input to the WUDAC letter on this subject. The following views are my own as a resident of Wheaton and do not reflect the views of WUDAC. I live approximately 5 blocks from the site.

I do not have the expertise to speak to the historical significance of the Wheaton Youth Center's architecture. The historical preservation commission's recommendation notes that "Keyes' design was well tailored to meet the needs of youth." The auditorium was designed for roller skating in the daytime and plays and concerts at night. Over time, the auditorium was modified so kids could play basketball. Would historic preservation require Wheaton's kids to return to roller skates or are we going to be allowed to change with the times? Times change, needs change, and designs change. If Keyes were alive, I suspect he would welcome the chance to design a new structure to meet today's needs.

The \$36 million were appropriated for recreation not historic preservation. If the Youth Center is designated for historical preservation then additional funds will be needed to preserve it and to redesign the Recreation Center around it. But it is my view that the community would receive greater benefit if the Youth Center were razed to allow for construction of a modern recreation complex.

The commission cites that examples of the architect's work have disappeared in other parts of the county. Thus they imply this increases the need to preserve this site. This would be a terrible insult to Wheaton, an already neglected and blighted area in the county, to have allowed other areas to develop and modernize while Wheaton is hamstrung because of past failures to preserve architecture.

The historical preservation commission suggests that the trees around the site have historic significance. They may have environmental significance, but the commission is inaccurate in calling them "original". Although they predated the Youth Center, they are not original growth. The Youth Center was designed and constructed to keep as many trees as possible, but already the boxwoods, hickory, birch and willow have been lost. What remains are locust, maple, and oak. The locust and maple have a life span of 70-100 years so a goal of preserving these trees is not possible to achieve.

Just as they did in 1963, the youth and citizens of Wheaton need a recreation center and the site of the old Youth Center has been selected and funds appropriated for that purpose. Designating the old building for preservation would deprive the public of this much needed new facility. May I suggest an alternative means of honoring the work of the late architect? Designate a wall in the new recreation center for photos and drawings and descriptions of the Youth Center and its history.



Dear Editor:

The Editorial titled "Rec center blues" in the October 30, 2013, Gazette is notable for what it omits or fails to understand and convey to the public. Please allow Montgomery Preservation to explain.

First, the historic designation process is intended to preserve buildings that physically define an architectural and social era. The Wheaton Rec center, designed by a distinguished architectural firm, is a unique classic representation of mid-20th Century modern institutional design. Its outstanding quality was recognized immediately with an award from the Potomac Valley Chapter AIA, and 50 years later it was equally lauded by scholars Gournay, Sies, and Longstreth as a significant mid-20th Century site.

The historic nomination is not about Led Zeppelin or other famous bands performing here. It is about the unique architectural impact of this building, its social relationship to Montgomery County, and its significance as a public recreation structure. Led Zeppelin's booking in a suburb illustrates the maturation of Montgomery County as a venue attraction to patrons and performers that could compete with D.C. clubs. This would have been impossible 10 years previously. In addition to the stage, it also had an indoor roller skating area, now used as the basketball court, and other rooms which continue to fulfill its ongoing community functions. Maintenance has been sparse recently, but no mold or odor is visible. This building is functional and repairable.

Some oppose historic designation for fear that preservation efforts will postpone a needed larger library and recreation center. That is not our aim, and there is

ample time in the planning process to include the Rec Center. The design team recently selected three site plan concepts to consider, one of which has the combined building and parking entirely on the library site, leaving the Rec Center site as green space. There is room for both historic and new buildings here.

Much of this controversy could have been avoided if County planners had assessed the history and significance of the Center earlier in the process. It fell to the Historic Preservation Commission to do its job of identifying and evaluating a threatened potentially significant Montgomery County structure. This project has been in process since the mid-1990s, so this clash could and should have been avoided.

Montgomery Preservation wants both: improved facilities for Wheaton and preservation with continued use of an outstanding architectural icon. It can be a win-win situation.
