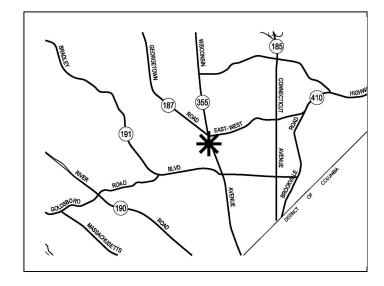

Summary

Staff Recommendation: Approval of the extension.

Section D-2.2 of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 90 days after the filing of a project plan. The Planning Board may, however, extend this period. Letters indicating approval and specifying conditions have not been received from several reviewing agencies. The applicant has requested, in a letter dated June 18, 2014, that the review period for the project plan be extended for up to 90 days, from July 27, 2014, until no later than October 25, 2014, to allow the reviewing agencies to respond.

Staff recommends **APPROVAL** of the extension request.

On behalf of Bainbridge Wisconsin Avenue Apartments LLC (the "Applicant"), we are submitting this request for an extension of the review period for the Applications. Pursuant to Section 59-D-2.2 of the Montgomery County Zoning Ordinance, the Montgomery County Planning Board (the "Planning Board") is required to hold a public hearing on a project plan application submitted under the optional method of development no later than 90 days after the filing. As a result, a Planning Board public hearing date on the Applications was tentatively scheduled for July 24th.
