## Description

# Outline of Charrette

The Charrette took place during the week of November 10 in the Westbard community. During the day the planning team met extensively with stakeholders from State and local agencies, Citizens Associations, property and business owners, and individual residents. On Monday, Wednesday and Thursday evenings the planning team held visioning and feedback sessions on plan concepts and ideas produced through interaction between the planning team, community and other stakeholders. On Tuesday evening, November 18<sup>th</sup>, the Westbard Planning team presented a Concept Framework Plan that resulted from the Charrette.

# Concept Framework Plan

The Concept Framework Plan took the extensive input received during the charrette and translated it into two Concepts with preliminary ideas for density, height, public facilities, transportation improvements, parks and open space as well as environmental considerations. The Plan seeks to transform the Westbard area from an auto-oriented suburban strip mall/service center into a pedestrian friendly, local town center that preserves the local services that the community depends upon.

## Next Steps

The Westbard Sector Plan team will spend the next several months refining the Concept Framework Plan. The team will continue to meet with the various stakeholders to address the various challenges and issues highlighted by the Concept Plan.
