

Summary

Staff Recommendation: Approval of the extension.

Section 7.3.3.C of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 90 days after the filing of a sketch plan. The Planning Board may, however, extend this period. Several complex issues raised at the Development Review Committee meeting of August 17, 2015, are still being resolved, including reconfiguration of the public open space areas and coordination with MCDOT on access issues. The applicant has requested, in an application dated September 24, 2015, that the review period for the sketch plan be extended for up to 61 days, from October 21, 2015, until no later than December 21, 2015, to allow the remaining issues to be resolved.

Staff recommends **APPROVAL** of the extension request.
