

Description

Location: Northeast quadrant of the intersection of 16th Street and East West Highway Zone: CR-3.0 C-0.75 R-3.0 H-145T Master Plan: Silver Spring CBD Sector Plan Property size: 9.77 acres Request to extend the review period for a project plan and site plan amendment for up to 2 months, from July 31, 2015, to September 30, 2015 Applicant: Falkland Road Residential, LLC Filing Date: December 3, 2014



Summary

Staff Recommendation: Approval of the extension.

Section 7.3.3.C of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 90 days after the filing of a sketch plan, and Section 7.3.4.C provides a 120-day limit for site plan hearings. The Planning Board may, however, extend these periods. Several complex issues raised at the Development Review Committee meeting of December 22, 2014, are still being resolved, including corrections to the forest conservation plan. The applicant has requested, in an application dated July 21, 2015, that the review periods for the sketch plan and site plan amendment be extended for up to 2 months, from July 31, 2015, until no later than September 30, 2015, to allow the remaining issues to be resolved. The review period for the sketch plan was previously extended by the Planning Director on February 23, 2015, for 30 days, from March 2, 2015, to April 2, 2015, and the review period for the sketch plan and site plan was extended by the Planning Board on April 2, 2015, for 50 days, from April 2, 2015, to May 22, 2015, and on May 14, 2015, for 70 days, from May 22, 2015, to July 31, 2015.

Staff recommends **APPROVAL** of the extension request.
