

Description

Request to extend the regulatory review period for Site Plan No. 820150140 an additional 2 months to December 8, 2016.

- Residential development consisting of 6 townhouse units on 0.5 acres of land zoned RT-12.5;
- Located on Hillery Way approximately 450 feet west of Rockville Pike (MD 355) within the White Flint Master Plan area;
- Application Accepted: May 3, 2016;
- Applicant: Alexander & Miry Livnat;
- Review Basis: Chapter 59, Montgomery County Code.



Summary

Section 59-7.3.4.C of the Zoning Ordinance generally states that a Site Plan application must be scheduled for a public hearing within 120-days after the date an application is accepted.

The Application was accepted on May 3, 2016, with a tentative Planning Board date of September 8, 2016. The Applicant made a timely request for a 30-day extension by the Planning Director, which was granted on July 27, 2016. The revised Planning Board date was set for October 6, 2016.

This timely extension request exceeds the 30-day extension granted by the Planning Director; therefore, it requires Planning Board approval. The Applicant is requesting an extension for the Site Plan review period, because there are a number of outstanding issues that will require more than 30 days to resolve.

Staff supports the Applicant's request to extend the review period, which sets a tentative Planning Board date on December 8, 2016.
