Plat Details: R-200 zone; 2 lots

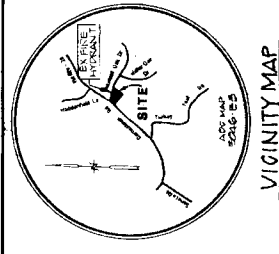

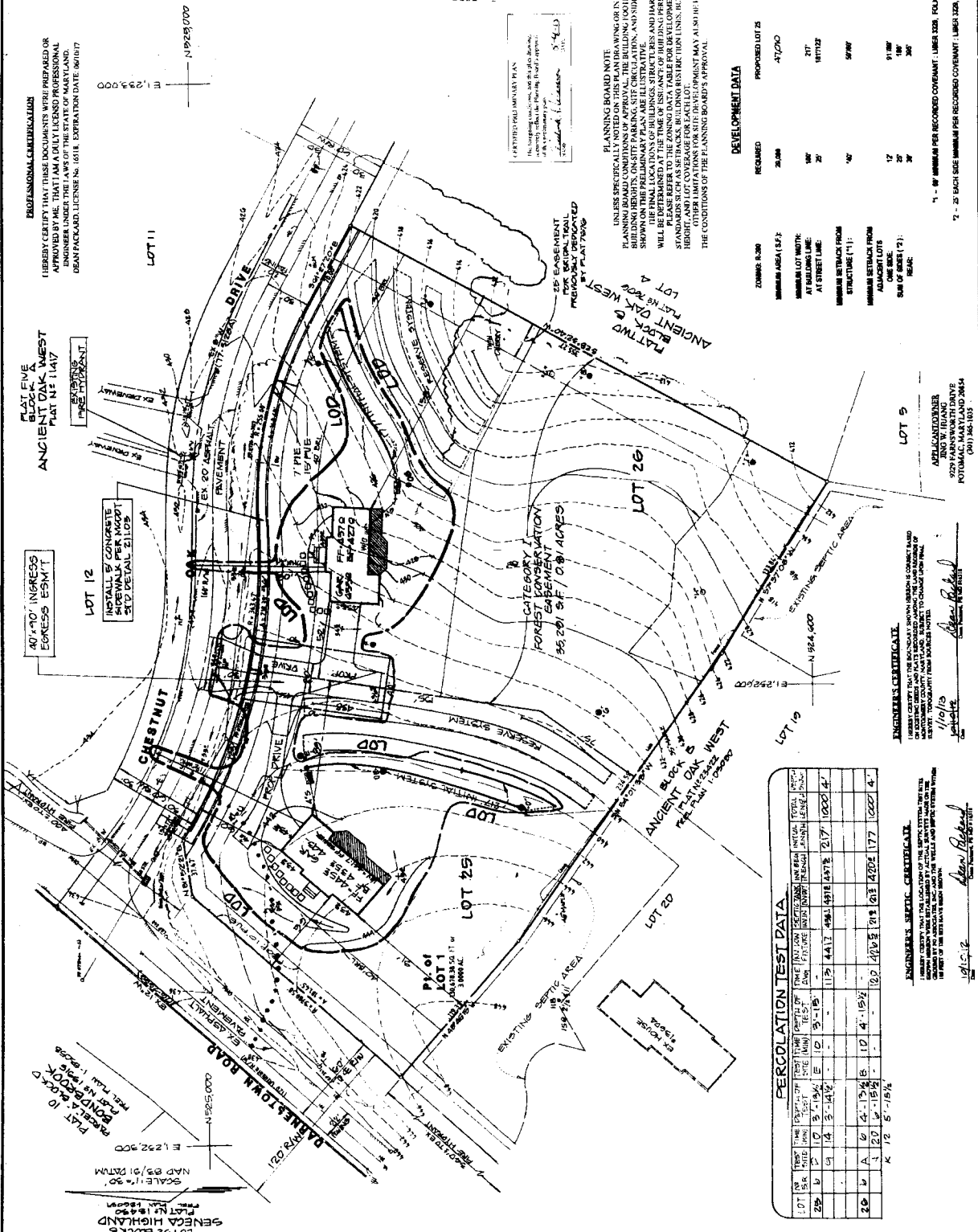
