

Summary

Staff Recommendation: Approval of the extension.

Section 7.3.3.C of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 90 days after the filing of a sketch plan. The Planning Board may, however, extend these periods. Several complex issues regarding Sector Plan conformance were raised at the Development Review Committee meeting of August 22, 2016. Planning and Parks Department Staff is working with the Applicant and the community to address these issues. The Applicant, in a letter dated January 30, 2017, is requesting that the review period for the sketch plan be extended from February 2, 2017, to February 23, 2017, to accommodate this on-going discussion. The Planning Board previously granted an extension of this review period, from December 8, 2016, to February 8, 2017.

Staff recommends **APPROVAL** of the extension request.
