**STAFF RECOMMENDATION:** APPROVAL of Sectional Map Amendment G-800 to implement the recommendations of the *Approved and Adopted Potomac Subregion Master Plan*.

## SUMMARY

Application G-800, a Sectional Map Amendment (SMA), was filed on June 21, 2002, by the Maryland-National Capital Park and Planning Commission to implement the Potomac Subregion Master Plan. The Montgomery County Council, sitting as the District Council, approved the Potomac Subregion Master Plan on March 5, 2002, and the Maryland-National Capital Park and Planning Commission adopted the Master Plan on April 11, 2002. The total area within the Sectional Map Amendment is approximately 40,583 acres. Approximately 890 acres are proposed for rezoning: the remainder, 39,693 acres, are proposed to be confirmed at the existing zoning.



## **BACKGROUND**

The *Approved and Adopted Potomac Subregion Master Plan* represents the culmination of a comprehensive master planning effort for the Potomac Subregion which commenced in 1999. The Plan amends the 1980 Master Plan for the Potomac Subregion, as well as other approved and adopted master plans, a list of which appears in the Plan document.

The Potomac Subregion Master Plan contains thirteen zoning recommendations that would be implemented through the SMA process. These are as follows:

Several of the above properties (1, 2, 6, 8, 12, and 13) are anomalies with split-zoned lots or parcels. The Master Plan recommendation on the latter two (12 and 13) is to correct the split-zoning on residential lots so that zoning lines follow property lines and lots are entirely within one zone.

Many other examples of split-zoning of residential lots currently exist in the Potomac Subregion. The previous comprehensive SMA covering the Potomac Subregion, G-247, was adopted in 1980, with Transfer Development Rights (TDR) Zone SMAs for Cabin John, Darnestown and Travilah (G-565, G-566, and G-567) adopted in 1987. The zoning lines in these SMAs followed property lines that predated the subdivisions and were not adjusted according to lot lines. This SMA, prepared on newly digitized maps, proposes corrections to adjust the zoning lines for split-zoned lots to coincide with property lines.

Attached to this report is a list of properties affected by this SMA. Because of the size of the Potomac Subregion, the SMA has been divided into three books (Book I, Book II and Book III), each with a separate Index. Book I generally covers Darnestown, Book II covers North Potomac, Travilah and part of Potomac, and Book III covers the south portion of Potomac. The index to each Book commences with parcels that are explicitly referenced in the Master Plan followed by parcels proposed for corrective amendments. The first 5 of 10 in Book I, the first 7 of 26 in Book II, and the first 2 of 13 in Book III are Master Plan amendments, the remainder being corrective.

Currently, there are no pending zoning cases within the boundary of the proposed Potomac Subregion Sectional Map Amendment.

## **CONCLUSION**

Approval of the Sectional Map Amendment will help implement the goals, objectives, policies and recommendations of the *Approved and Adopted Potomac Subregion Master Plan*. Staff, therefore, recommends approval of Sectional Map Amendment G-800.

SUBJECT: Potomac Subregion Master Plan Sectional Map Amendment (SMA)

Dear Property Owner:

The purpose of this letter is to furnish you with some background and details regarding the above Sectional Map Amendment (SMA), and to provide you with a contact name and telephone number if you have any questions.

**BACKGROUND:** On March 5, 2002, the County Council, sitting as the District Council, approved the Potomac Subregion Master Plan by Resolution No. 14-1170. On April 11, 2002, the Maryland-National Capital Park and Planning Commission adopted the Master Plan by Resolution M-NCPPC No. 02-05.

Once a master plan is approved and adopted, a Sectional Map Amendment (SMA) is filed to implement the zoning recommendations in the master plan. The Potomac Subregion Master Plan contains thirteen zoning recommendations that would be implemented through the SMA process. These are as follows:

Several of the above properties (1, 2, 6, 8, 12, and 13) are split-zoned lots or parcels. The recommendation on the latter two is to correct the split-zoning on residential lots so that zoning lines follow property lines and lots are entirely within one zone.

Many other examples of split-zoning of residential lots currently exist in the Potomac Subregion and this letter is being forwarded to the owners of record of such properties. The previous comprehensive SMA covering the Potomac Subregion was adopted in 1980 with minor amendments in 1987. The zoning lines in these SMAs followed property lines that predated many subdivisions and were not adjusted according to lot lines. This SMA constitutes a comprehensive technical correction in order to remedy split-zoning and to enable zoning lines to coincide with property lines. The following is a very brief summary of the corrective amendments in the SMA:

**Book 1      Parcels 5-10**

These properties on High Meadow Way and High Meadow Road, Darnestown, are in various combinations of split-zones and are proposed for minor adjustments according to the primary zone. The Coffman property (Parcel 614) will remain split-zoned between RE-2 and R-200 after these minor adjustments, as to do otherwise would constitute a major change.

**Book 2      Parcels 8-9**

These properties on Hunting Lane, North Potomac, owned by the Christian Covenant Church and Stonebridge Homeowners Association, are split-zoned R-200/PD-3 and are proposed for minor adjustments to remedy this.

**Book 2      Parcel 10**

These properties, south of the Johnson property on Travilah Road, are split-zoned RE-2/R-200 and are proposed for the RE-2 zone.

**Book 2      Parcels 11-12**

These lots, on Valley Drive, Cherrydale Drive, and Pheasant Drive in Piney Glen Village, are split-zoned R-200/RE-1, or R-200TDR/RE-1, and are proposed for the R-200 or R-200/TDR zones.

**Book 2      Parcel 13**

These three lots, on Cloverbrooke Drive and Cloverbrooke Court, are split-zoned RE-1 and R200/TDR and are proposed for the RE-1 zone.

**Book 2      Parcel 14**

Two of these properties on Lakewood Drive are split-zoned RE-1 and R-200. The remaining lots, which range in size from 40,000 to 213,000 square feet, are zoned R-200. All are proposed for the RE-1 zone.

- Book 2      Parcels 15-16**  
These lots, on Falls Road, Victory Court, Victory Lane, and Liberty Lane, Potomac, are all split-zoned R-90 and R-200. Lots are proposed for either the R-90 or R-200 zone, whichever is most appropriate.
- Book 2      Parcel 17**  
These lots, on Tuckerman Lane, Potomac, are split-zoned R-90 and R-200. All are proposed for the R-90 zone.
- Book 2      Parcels 18-19**  
These three properties, on South Glen Road, are split-zoned RE-1 and RE-2. Properties are proposed for either the RE-1 or RE-2 zone, whichever is most appropriate.
- Book 2      Parcels 20-21**  
These lots, on Bells Mill Road, Cambridge Manor Court, Sweetwater Drive, and Nantucket Court in Potomac, are split-zoned R-200 and RE-1. Lots are proposed for either the R-200 or RE-1 zone, whichever is most appropriate.
- Book 2      Parcel 22**  
These three lots, on Willow Run Court in Potomac, are split-zoned R-200 and R-150. Each is proposed for the R-150 zone.
- Book 2      Parcels 23-25**  
These lots, on Tuckerman Lane, Willowbrook Drive, Fox Run Drive, and Fox Run Road in Potomac, are split-zoned in various combinations of R-90, R-150 and R-200. Lots are either proposed for the R-90 or R-150 zone, whichever is most appropriate.
- Book 2      Parcel 26**  
This single parcel, off Cavanaugh Drive, is split-zoned RE-1 and R-200/TDR, and is proposed for the RE-1 zone.
- Book 3      Parcels 3-5**  
These properties on South Glen Road, Normandie Farm Drive, and Apple Hill Court in Potomac, are split-zoned R-200/TDR and RE-2/TDR. The properties are either proposed for the R-200/TDR or RE-2/TDR zone, whichever is most appropriate. One lot, on South Glen Road, is split-zoned RE-2 and R-200, and is proposed for the RE-2 zone.
- Book 3      Parcels 6-7**  
These lots, on Sorrel Avenue, in Potomac, are split-zoned RE-2 and R-200. Lots are either proposed for the RE-2 or R-200 zone, whichever is most appropriate.

- Book 3      Parcels 8-9**  
These lots, on Great Arbor Drive and Willowbrook Drive, in Potomac, are split-zoned R-200 and RE-2. Lots are proposed for either the R-200 or RE-2 zone, whichever is most appropriate.
- Book 3      Parcel 10**  
These lots, on Willowbrook Drive and Newbridge Drive in Potomac, are split-zoned RE-2 and R-200. The lots are proposed for the RE-2 zone.
- Book 3      Parcels 11-12**  
These lots, on Gainsborough Road, Windsor View Terrace, Snug Hill Court, Scarboro Court, Windsor View Court and Windsor View Drive in Potomac, are split-zoned R-90 and R-200. Lots are proposed for either the R-90 or the R-200 zone, whichever is most appropriate.
- Book 3      Parcel 13**  
These properties, on Falls Road south of River Road, Stanmore Drive, Burbank Drive, and Bit and Spur Lane in Potomac, are split-zoned RE-2 and R-200. All are proposed for the RE-2 zone.
