POLICY: CPTA 02A-CH1-01: Piney Branch Sewer Restricted Access Policy Revision

#### RECOMMENDATION:

Approval of staff recommendations and transmittal to the County Council and County Executive.

The July 2002 transmittal contains 45 proposed water and sewer map amendments (18 current category change requests and 27 previously deferred Potomac Subregion Master Plan Cases) and 1 proposed plan text amendment for the Piney Branch Sewer Restricted Access

Policy. The JULY 2002 County Council Amendments to the *Comprehensive Water Supply and Sewerage Systems Plan* applications have been reviewed for consistency with water and sewer service recommendations within their respective master plans. Staff recommendations are based on master plan guidance and other policies within the *Comprehensive Water Supply and Sewerage Systems Plan*. Staff is in agreement with the Executive staff's recommendations on all submitted cases.

#### **DISCUSSION:**

The attached material contains forty-five water and sewer category change requests under consideration as amendments to the *Comprehensive Water Supply and Sewerage Systems Plan*. Amendment policies are discussed on pages 1-9 through 1-18 of that Plan (see Attachment). The comments and recommendations of the WSSC, MCDEP staff, and Park and Planning staff are incorporated into the Summary Table of Category Change Requests (See "Proposed Amendments: Montgomery County Comprehensive Water Supply and Sewerage Plan; County Executive's Amendment Transmittal to the County Council-July 2002," Attachment).

Unlike applications considered under the Administrative Delegation process, these applications must be forwarded to the County Council for action. The Planning Board is required by state law to provide land use and zoning input on these amendments. Planning Board recommendations will be forwarded to the Council prior to public hearing record closure and in time for the T&E work session on 14OCT2002.

Attachment 1 of this packet is the County Executive's Amendment Transmittal to the County Council-July 2002, containing forty-five applications. Park and Planning Staff recommendations concur with the Executive staff recommendations for all requested changes. A discussion and brief summary of the individual applications follows. More detailed information and maps can be found in Attachment 1.

#### BENNETT AND LITTLE BENNETT PLANNING AREA

Route 355 Business Corridor, Concur with Executive's Recommendation; Approve W-4 with advancement to W-3 conditioned on: 1) confirmation from the applicants that the proposed water main extension is financially feasible, and 2) inclusion of the required capital water main project in the WSSC CIP.

Linda Polk (for Patricia Buck Trust), Concur with Executive's Recommendation, Approve S-1 for one sewer hookup only.

## WSCCR 02A-BEN-03: Circle Page 22

Or Chadash Partners, LLC., Concur with Executive's Recommendation, Maintain W-1 and S-1 restricted to single water and sewer hookups only. Applicant is requesting single hookup use for a proposed 300-seat synagogue for a RDT zoned property. Single sewer service hookup

refers to one residential hookup. Substantive concerns exist with regard to the Water and Sewer Plan's private institutional facilities (PIF) policy. County Executive's recommendations have recently recommended deferral on PIF related cases pending Council action on the PIF policy in the next full Water and Sewer Plan update. Staff recognizes that the Private Institutional Facilities policy has resulted in unintended land use conflicts, particularly in RDT zoned areas. Impacts of the PIF policy include significant expansions of impervious area for some applications, water quality impacts, transportation increases, etc. Staff recommends approval of WSCCR 02A-BEN-03, acknowledging concern regarding PIF policy review.
