#### SUMMARY

From 1976 to 2001, a total of 129,184 units have been produced including 10,993 Moderately Priced Dwelling Units (MPDUs). Currently, an opportunity exists to develop Metro stations as mixed-use centers—providing for new housing possibilities. There are over 600 MPDUs pending at Metro stations that have been reviewed in the last two years but have not yet completed the preliminary plan review process. In order to achieve production of the future housing units, these Metro station area projects should be a priority in the regulatory process.
