STAFF RECOMMENDATION: APPROVAL

PURPOSE OF THE TEXT AMENDMENT

To amend the Zoning Ordinance to eliminate authority of the District Council to decide a cemetery and family burial site special exception.

BACKGROUND/ANALYSIS

The grant of a special exception for a cemetery and family burial site is the responsibility of the District Council and not the Board of Appeals. It is the only remaining special exception that the District Council decides. ZTA 03-25 would assign the responsibility for deciding a cemetery special exception to the Board of Appeals. The grant of a special exception for a cemetery was once associated with the issuance of a permit which was the responsibility of the Council. This is no longer the case. The Screening Committee in reviewing the proposed ZTA did not see any particular reason that the District Council should continue to review cemetery special exception applications.

The proposed text amendment language is as follows:

59-G-1.13. [District Council.] Reserve.

[The District Council has the sole authority to decide the following special exceptions, subject to relevant provisions of Section 59-G-1.2, Section 59-G-1.3, and Division 59-G-2.

Cemeteries and Family Burial Sites.

The Hearing Examiner may issue written reports and recommended findings, decisions, orders, and recommend conditions of approval to the District Council on applications for these special exceptions.]

Staff has no objection to the elimination of County Council review of special exceptions for cemeteries and family burial sites since the use will continue to be reviewed under the standards and conditions of Article 59-G of the Zoning Ordinance. Further, the proposed requirement for review by the Board of Appeals is consistent with the review procedures for all other special exceptions in the county.

RECOMMENDATION

The staff recommends approval of the proposed text amendment to amend the Zoning Ordinance to eliminate authority of the District Council to decide a cemetery and family burial site special exception.

Sec. 1. Division 59-G-1 is amended as follows:
