SUBJECT: Strategic Plan for Economic Development

The Department of Economic Development (DED) and members of the Economic Advisory Council Strategic Plan Steering Committee briefed the PHED Committee on the proposed Strategic Plan for Economic Development in June 2003. The Committee was briefed on the substance of the proposed plan, the process used in developing the plan and the level of participation of those involved in developing the plan. The County Executive is requesting that the Council adopt the Plan as the official economic development strategy for the county. David Edgerley and Tina Benjamin from DED will be present for the discussion.

At the June meeting the Committee recommended specific revisions to the plan. David Edgerley has forwarded a redrafted plan reflecting the Committee's revisions. The majority of the changes can be found in the Executive Summary and in Section II, Strategic Goals and Actions Plans. The new plan deletes all references related to government funding expectations. There is also an increased emphasis on the role of arts and culture, opportunities resulting from the presence of Federal agencies, venture capital and small businesses and minority/female/disabled-owned businesses. The additions to the plan are in italics and the deletions are underlined. Staff has placed check marks in the margins to highlight changes.

The PHED Committee also made the following general recommendations:

Summary of Programs – In conjunction with the Plan, there should be a summary of economic development and business incentive programs available to the county business community.

Implementation – A plan for the implementation of the goals of the Strategic Plan should be developed.

Tracking – Updates on the Plan should be presented periodically to the PHED Committee.

After discussion of the revised Plan, the Committee should decide whether to forward the Plan to the Council for approval as the economic development strategy for the county.
