#### Carolyn:

Here are the costs we incurred for the First Annual Turkish Festival held in Cabin John Regional Park on Saturday, August 30th and Sunday, August 31, 2003.

Labor Costs - Saturday, August 30, 2003 - \$2, 460.57(OTP) Sunday, August 31, 2003 - \$2, 432.02 (OTP)

#### Labor Cost Total - \$4,892.59

( NOTE - Labor consisted of one (1) Park Manager, one (1) Work Leader and six (6) Park Maintenance Workers per day. Park Managers flexed their day or earned compensatory leave.)

Transfer Station Costs - \$56.88 (1.185 tons)

#### TOTAL COSTS - \$ 4,892.59

There were no additional charges for clean-up after the end of the festival. The organizers dismantled tents and picked-up all ground litter while park staff folded tables/chairs and stacked them at the amphitheater for retrieval. Leaders accounted for all tools used by the festival organizers and Park Police. Signs were removed by fiex crews on Monday, July 1, 2003 incurring no additional costs. August 30th activities were cut short by a heavy rain at 2:00pm. August 31st was an overcast day with chance of showers, rain did not occur until after the event concluded and clean-up was completed.

Overall Review: There were no real problems associated with the Turkish Festival but barring rain, and a greater push on advertising the festival has the possibility to grow which would increase the chance for overcrowding the Family Picnic Area of Cabin John Regional Park.
