SUBJECT:

FY06 User Fee Schedules - Enterprise Fund

STAFF RECOMMENDATION: Approval of Proposed FY06 Enterprise Fund User Fees.

Staff presented the full fee recommendation packet to the Planning Board on July 22, 2004. At that time, staff indicated that we were seeking approval that day only for the proposed fee changes for the Conference Centers, Brookside Gardens, and the stable operations. The remaining fees would be presented to the Planning Board during the FY06 budget process. The fee recommendations presented herein are for both FY05 and FY06, and any increased revenue generated from these fee recommendations are designed to support the strategic plan for the Enterprise Division (see below) and will be included in the FY05 Estimated and FY06 Proposed budget submissions.

Since July 2004, when the Enterprise Division was formed, staff has developed a strategic plan for the division. Enterprise fees and fee structures are one of the elements we considered in developing the plan. As we work further towards refining the plan, we will continue to evaluate our fees, and, if the plan calls for significant changes in the proposed fees herein or the manner in which Enterprise fees are established and changed, staff will return to the Planning Board with the proposed changes.

Background

In accordance with the Department's Policy on User Fees, Enterprise user fee recommendations go to the Planning Board on an annual basis. Prior to developing the proposed user fee schedules, staff conducts surveys of other local jurisdictions' user fees for similar facilities. These surveys were provided in the July 22nd packet and copies will be available at the meeting for review. This information, in concert with input from our facility managers, attendance information and user patterns for each facility, and the financial picture of individual facilities and the Enterprise Fund as a whole, is used to draft the recommended schedule of fees.

Consistent with the Department's User Fee Policy, user fees for self-supporting Enterprise facilities, services, and programs are established at a level which (1) is competitive with comparable public and private facilities and services in the area; (2) can reasonably be expected to generate sufficient revenue to sustain administrative, operating and maintenance costs; (3) is likely to generate surplus operating income to fund capital improvements at existing and developing facilities; and (4) reflects user demand and patterns of use.

Not all fees are recommended to increase or change on a yearly basis. Some fees, such as security deposits, are not necessarily affected by market influences or inflation, and may remain unchanged for several years running. Fees for certain family oriented activities, such as boat rentals, the carousel, and train rides, remain fairly static in the marketplace over a period of years, with only occasional, incremental increases, which we try to mirror or even initiate. In other instances, it is a judgment call by staff to leave selected fees at current and past levels in order to enhance usage, and/or when we believe a particular product or service level we offer does not command a fee commensurate with or higher than other competitive facilities.

For FY06, staff is recommending the following changes in the Enterprise Fund user fees. A full listing of the fee schedules is provided in Attachment 1.

Golf Courses -

- Northwest and Needwood Golf Courses –increase all the weekday 9-hole greens fees by \$1.00 in FY05 and \$0.50 in FY06. Increase the weekend 9-hole greens fees \$3.50 in FY05 and \$0.50 in FY06. Increase all the weekday 18-hole greens fees by \$2.00 in FY05 and \$1.50 in FY06. Increase the weekend 18-hole greens fees \$4.50 in FY05 and \$1.50 in FY06. For the Needwood Executive 9, increase the weekend 9-hole greens fee by \$1.00 in FY06.
- Sligo Golf Course In FY05, increase the all greens fees except the junior rate by \$0.50 for 9 holes and \$1.50 for 18 holes.
- All courses –In FY05, increase the 18-hole golf cart fee by \$1.00 and the summer program fee by \$0.50 per hour.

Ice Rinks -

- Cabin John and Wheaton Ice Rinks increase the admission fee for the dance sessions by \$1 and the moves/freestyle sessions by \$0.50 in FY05.
- Wheaton Ice Rink increase the pick-up hockey and speed skating sessions by \$1.00 each in FY05.
- All rinks increase the leased ice rental fee by \$15 to \$20 per hour in FY05.
- Cabin John Rink increase the leased ice rental fee for the small rink to \$160 per hour in FY05.

Indoor Tennis -

Cabin John Tennis - In FY05, increase the summer 6am and 10pm daily fee by \$2 per hour
to match the fees charged the remainder of the day; increase the hourly group lesson fee for
beginners and intermediates to \$16 and \$18 respectively; and increase the summer program
fee to \$10 per hour.

Park Facilities -

- Boating operations In FY05, increase the rental fee for pedal boats from \$5 to \$5.50 per half hour at Lake Needwood; increase the rental fee for rowboats and canoes from \$21 to \$23 per day at both lakes; increase the annual mooring fee from \$65 to \$70 per year at Black Hill; and introduce a mooring fee at Lake Needwood of \$50 per year. In FY06, increase the annual launching permit from \$55 to \$60 at both facilities and increase the daily permit at Lake Needwood from \$4 to \$5 bringing it up to the current fee charged at Black Hill.
- Little Bennett Campground In FY05, staff proposes a restructuring of the campground fees
 by eliminating the differential between resident and non-resident fees. For campsites without
 electricity (tent sites), staff recommends fees of \$17 and \$19 for weekday and weekend
 camping respectively. For campsite with electricity (RV camping), staff recommends fees of
 \$24 and \$26 for weekday and weekend camping respectively. The Enterprise Division plans
 to increase our campground offerings by building cabins to rent. Staff recommends
 introductory fees of \$40 and \$45 for weekday and weekend cabin camping respectively.
- Picnic pavilions at Black Hill Regional Park In FY05, increase the rental fee by \$20 for the large pavilions.
- Agricultural History Farm Park In FY05, introduce a new fee of \$5 per person for the
 interpretive program provided at the Farm Park. This fee is in-line with the new fee charged
 at the Nature Centers per the direction of the County Council. The primary users of this
 interpretive program are the students of the Montgomery County Public School system.
- South Germantown Miniature Golf In FY05, introduce a junior fee of \$4 per round for ages 10 and under. In FY06, increase the admission fee for the Splash Playground from \$3.50 to \$4.00. The discount ticket books and group fees increase commensurate with the admission fee.
