Dear Chairman Berlage:

Since the Fairland Golf Course Community will apparently not be constructed as planned (and as discussed in the 1997 Fairland Master Plan), I suggest that the existing Old Gunpowder Golf Course would serve as an excellent reforestation site to replace some of the wooded areas to be taken along the master-planned route of the InterCounty Connector.

The golf course is a good reforestation site for the following reasons:

- It is in the Little Paint Branch Watershed part of the larger Anacostia River Watershed;
- It is located in Montgomery County<sup>1</sup>;
- The land is, as I understand it, already owned by the M-NCP&PC;
- The course is not a positive contributor to water quality in the Little Paint Branch; and
- The Montgomery County Planning Board and Montgomery County

#### Road right of way

The Planning Board also authorized the purchase of the Sue W. Layman property in Derwood.

Located at 6917 Garrett Road, the 5.91 acres lie along the right of way of the Intercounty Connector and the proposed Mid-County Highway extensions. A road is expected to be built through Derwood to connect Mid-County Highway with the proposed ICC.

Mid-County Highway was designed as an alternate to Route 355 and Interstate 270, connecting Shady Grove Road to Damascus. Only a section of the roadway exists, running from Shady Grove Road to Montgomery Village Avenue.

The Garrett Road property would be purchased through the Advanced Land Acquisition Revolving Funds, a program designed to buy land slated for public use that otherwise could be lost to private development, said Bill Gries, land acquisition specialist for Park and Planning.

The County Council must authorize the sale.



As you know, this extension of Mid-County Highway would skirt along yet another boundary of Mill Creek Towne - leaving us totally surounded by high speed roads - with yet another one going right through our middle.

This highway extension would also separate the whole of Mill Creek Towne from Redland Park, which was built after active campaigning of the citizens of Mill Creek Towne. I have a question of safety which I feel must be addresses BEFORE any road construction begins. How are the residents of Mill Creek Towne going to get to the park SAFELY? You are either going to built crossing lanes - which will inevitably lead to someone being struck, injured or killed while attempting the crossing.

The safest alternative would be a tunnel. However, I must say that we don't exactly trust the county when it comes to tunnels. The county promised us last winter that the lighting in the tunnel, which has been out for many years, would be restored by late spring. It is the middle of summer and there is no lighting in that tunnel.

The tunnel under Shady Grove, while being cared for by the County was a pig sty. It was full of garbage, graffiti, and dangerous debris. I finally arranged for a local firm to take on the maintenance of the tunnel (with my assistance) so we would have, at least, a clean tunnel to walk through. I don't know that they would be willing to take on yet another tunnel to maintain. Even now, we still fight the graffiti. I, armed with one small razor blade, am no match for the vandals.

Our question is have you given any consideration to the fact that this will be a major problem for our community. Children's soccer games will be going on right up against a major thoroughfare.



Dear Chairman Berlage and Commissioners:

As president of the Stonegate Citizens Association representing 1300 households adjacent to the Intercounty Connector, I wish to state our opposition to MNCPPC acquiring property in other areas of the county to mitigate the impacts of the ICC.

The selected alignment of the ICC that would cross the Northwest Branch near Bonifant Road would greatly impact our community. Therefor, we would like to highlight the impact and proposed mitigation recommended in that watershed.

ICC Corridor 1 with Northwest Branch Option 1, will impact 46.3 acres of parkland and 60.5 acres of Interior Forest in the Northwest Branch Watershed. Both MDOT and the MNCPPC Staff recommendations allow only 23.2 acres (Llewelyn Fields), which is to be developed into ball fields, as the only replacement in our Watershed. No forest at all!

Since it is not possible to adequately mitigate the loss of the natural resource functional values in the impacted watersheds, MNCPPC should not permit these irreplaceable parklands to be destroyed. The community of Stonegate would be deprived of a peaceful sanctuary that serves our immediate neighborhood.

The ICC would be the single most environmentally destructive project ever built in the County. If you as commissioners of the MNCPPC permit our parks to be destroyed, you are not upholding your responsibilities to be stewards of our park system.

#### Dear MNCPPC:

This is to request (no, beg) that you do not approve the ICC mitigation plan that fails to adequately protect Montgomery County's unique and special parklands and natural areas. The parklands and other areas slated for the ICC are habitats for an abundance of wildlife and provide countless opportunities for residents of the area to enjoy the serenity and beauty of nature.

As stewards of our parkland, Park and Planning is responsible for protecting our parklands. Accepting the staff-recommended mitigation would be ignoring the agency's stated mission. The ICC would be the single-most environmentally destructive project ever built in the County. This destruction need not be the legacy of the current MNCPPC.

While the MNCPPC proposed mitigation provides compensatory parkland, the vast majority of it is far outside the impacted watersheds. So residents in the proposed ICC corridor are "compensated with" parkland miles away from their homes while left with the noise, pollution and destruction of a superhighway. Is the permanent loss of recreation areas for the local communities and unique ecological function for concrete and congestion a fair exchange?

The MNCPPC proposal does absolutely nothing to compensate for the loss of natural resource values in the Mill Creek, Rock Creek, North Branch, or Northwest Branch watersheds. Although Paint Branch is thrown "a bone," it does not compensate for the enormous impacts to Paint Branch Park including the critical Good Hope trout spawning tributary that would be degraded beyond recovery if the ICC were to be built. It is simply not possible to adequately mitigate the loss of natural resource functional values in the impacted watersheds.

Yes, we beg you to not allow the State Highway Administration to destroy irreplaceable parklands. It is YOUR obligation to protect our parklands. If you allow the SHA to destroy our parks, MNCPPC is not upholding its responsibilities to be stewards of our park system. THE ICC SHOULD NOT BE BUILT!

Dear Chairman Berlage and members of the Planning Board,

Throughout the past five years, I have been actively involved in the planning process in the communities of Upper Rock Creek, Olney and Shady Grove. I have heard countless times that the community should "trust" Park and Planning to be the best stewards of natural resources, protection of the intents of Master Plans, determination of adequate infracture prior to new development. Long before the major violations in Clarksburg, the communities have known that this request for "trust" is often lip service as the Planning Board and the County Council have bowed to the pressure for unbalanced and far too rapid growth.

Now they propose to run a six-lane arterial highway through the heart of that narrow woodland valley—destroying forever its true and immeasurable value to the city and the nation."
