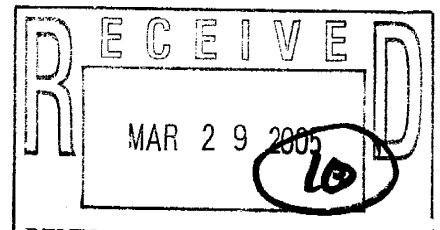
I am currently renting the property next to the project mentioned above. I attended the meeting held on Monday March 14th on behalf of my landlords who live in Arizona, as well as as the person who lives next door.

I rented this property because it's beautiful, and peaceful, and I know there is nothing I can do, but live with the noise and the commotion which are going to happen next door.

But I do have some concerns, and wanted to share them with you. I am a single Mom, and have two beautiful teenagers daughters. It's going to be summer, they are probably going to be outside a lot, and I am very concerned with tens of workers being next door.

I am going to be completely isolated from the rest of the neighborhood, and I work, so I am not home that often during the day. I still have in my mind the rapes and murders of the Potomac family a few years ago by a construction worker.

I know that most of these workers are good men making a living, but how can I be sure that there is no bad apple in the bunch? Is it possible to screen them for child molestation and rape records? I am just scared to leave my daughters alone with workers so close from where we are. (picture enclosed)



In the second picture I am enclosing, you can see that my long and private (not for long anymore!) driveway is just a foot away from the other property, and that workers will have to work very close by since there is a house in ruins which needs to be tear down. Is there any way that they can separate the two properties with a construction fence (like they do in the cities) in order to have at least something between us.

I also have dogs with an invisible fence, and they are going to spend their time trying to get to the other side if there is nothing between us.

I know it is a lot to ask, but I am just very concerned. It's such a peaceful place right now, that no, I am not looking forward to have to deal with noise and so on for many months, but my main concern is safety.

I will be out of town this coming week, and will be returning on April 1st. I want to attend your next meeting. I did call your office, but they did not have any date scheduled yet.

② is the house in ruins which will be destroyed (As you can see it's a few feet away from the property I'm renting).


