In particular the property on Griffith Road is located in the Agricultural Reserve which once developed will take away land that is a vital and valuable industry of our counties economy.

While I understand the desires of the Derwood Bible Church I feel the scope of the development is out of scale for the community and natural resources for the property. Other entities have restrictions set by the Council of Parks and Planning, and I am asking that we not allow for PIF's to receive a category change that would allow an exception to this measure. Mr. Berlage,

I'm writing to you to express my deep concern over the possible loss of agricultural land in Montgomery County. I'm sure you are aware of the issues of PIF's and Ag Reserve, but there seems to be a rapidly accellerating trend to convert Ag to non-Ag use through the PIF process. Some people would like to make this an issue of religious groups right to worship, but as an active member of a church in Montgomery county I would like to say that in my opinion this is NOT the issue. The issue is a growing trend that will destroy agriculture in Montgomery county if not controlled. There are two properties that I know of in the county that are examples of this, the 225 acres on 108 and Griffith road and a 50 acre tract on Hawkins Creamery. The Griffith road piece is now farmed in a rotation of corn, wheat and soybeans. My limited knowledge of these types of crops and the large investment in the machinery necessary to harvest them concerns me that when enough land is removed from the farmers it will no longer be viable to maintain the critical mass of land necessary to make a living from farming and that it will vanish. The Hawkins Creamery piece is now an equestrian facility. This type of business is one of, if not the largest ag related business in the state of Maryland. This equestrian business is being closed in October.

The other issues are the large amount of traffic that most of these PIF will bring to the Ag preserve area from all over the county. These are not neighborhood or ag related facilities. They also require a considerable amount of water and septic capacity which may impact the ground water of the areas surrounding them which rely on wells and septic. For example, the Griffith road property development application calls for 20,000 gallons of water per day peak use. If the property were developed for maximum homes as allowed in the Ag reserve zoning it would support 9 homes at 500 gallons/day, or 4,500 gallons/day peak. I URGE you to deny the application for this permit because of it's adverse impact on the environment and the local community. If you do not feel that you can do this now, at least delay decision and hold hearings to get a better understanding of the issues.

Other suggestions related to PIF's on Ag Reserve lands are:

- Restrict water use by PIFs to 5,000 gallons per day peak use (agricultural use exempt)
- Do NOT allow water/sewer category change to set the precedent which will lead to many more PIFs in Ag Reserve
 - Treat private institutional facilities in the Ag Reserve as "special

exceptions" requiring hearings

I do feel that many of the institutions desiring to use the Ag reserve for non-Ag purposes are playing the highly political "religious freedom" card simply to make reasonable control of the Ag reserve too painful for politicians and county governments to fight. Please consider what the Ag reserve was intended to preserve in Montgomery county. Once real farms start to fold in Montgomery county we will have lost an unreplacable resource, AND I think this is closer to reality than many believe. The system has worked well in the past and PIF's have not been a problem to date, but the pace is accellerating at an alarming rate.



I am writing to voice my concerns over the proposed development of the Derwood Bible Church property at Griffith Road and Rt. 108 just North of Laytonsville Maryland. This "Megachurch" will is proposed to have a 1500 member congregation, a home for trouble teens, a High School and many other facilities which are inconsistent with the Rural way of life praised by those who choose to live outside of the suburbs.

This land is set within the Montgomery County Agricultural Reserve. The Agricultural Reserve, as you know, was created some 25 years ago with the intention of preserving agricultural land and rural open spaces. When the Agricultural Reserve was created, some exceptions were granted which would allow certain entities, such as places of Worship, to build on the Reserve. When a Government provides a special exception to a Religious organization to build on land such as the Agricultural Reserve, yet denies that same right to private entities, the Government has crossed the line in the separation between Church and State.

The Agricultural Reserve guidelines allow for one house to be build per 25 acres. Typically, one house would serve an average of 4 people. The plans for the 230 acre Derwood Bible Church lot seek approval for a 1500 member congregation which is significantly more than the same area would typically be allowed for housing, 36 people in 9 houses on the same 230 acres. By allowing this proposed development to take place, you would be allowing an increase in over 38 times what the Reserve would typically be permitted to accommodate. Can you imagine the horror of dismissing the Zoning Ordinance within the City of Rockville and allow private entities the right to build 38 times the existing FAR, Floor Area Ratio? I submit to you that this would be Chaos. The WSSC sewer lines alone would be overloaded from the very beginning to say nothing of the increased number of people which would inevitably come along with such development. The infrastructure, from the utilities to the roads would have to be re-engineered to even determine if it were even possible to do such a massive project in the first place. It would also take years of destructive construction. This is exactly what is happening in this case. The Derwood Bible Church proposed development will tap into the existing aquifer which provides water to the town of Laytonsville residents. The increased withdrawal of water from this aquifer can lead to general water-level declines and will affect nearby domestic wells potentially causing them to go dry. Additionally, the installation of a new septic system for a facility of this magnitude will be an engineering feat within itself. The failure of such a huge system would contaminate the aquifer and devastate the way of life. Additionally, just trying to get 1,500 people to the new facility, through the tiny town of Laytonsville, which has one whole traffic light, will cause complete and total gridlock as people try to get to and to leave each service numerous times each day. Emergency vehicles will simply not be able to go anywhere as the two way streets in and out of Laytonsville, will be completely congested.

This is not a matter of anyone or any group being anti-religious, it is more a matter of keeping the scope of a project within guidelines which will not forever cripple a town. In this case, the town would be Laytonsville. By allowing this proposed "Megachurch" the right to build on this sacred land, the Council would be setting a precedence which would allow virtually all of the Reserve to become built upon. This should not be allowed to happen. Please do not approve this type of development.

I appreciated the strong support you expressed at the League of Women Voters' forum on Monday.

As an economic paradigm, sustainable agriculture creates decent paying jobs (\$10.00 per hour minimum versus \$5-6 for janitors), and has tertiary economic spin-offs that create small-scale industries and higher paying jobs, in addition to valuable environmental benefits. Sustainable agriculture is a revenue enhancer, requiring less infrastructure than it returns in revenues to local and state coffers; other types of development are a revenue loss.

The County Council has also not paid attention to sound research documenting the importance of a safe, sustainably produced, local food supply that reinforces a strong rural economy, significantly enhances local and state revenues, reduces global warming, and enhances ecosystems. Farm to institution programs also reduce health care costs by dramatically improving nutrition. Schools that have replaced junk food with farm fresh food have experienced dramatically improved behavior and performance, reducing the need for additional services and support personnel. Food production agriculture in Montgomery County needs to be protected and enhanced, not eliminated.

Some things truly are priceless, don't let the developers convince you otherwise.
