SUMMARY OF AGRICULTURAL INITIATIVES

INTRODUCTION

The Master Plan for the Preservation of Agriculture and Rural Open Space was approved and adopted 25 years ago. The implementation of this Master Plan has fostered the creation of a thriving greenbelt of active agricultural and rural open space. Montgomery County and state programs supporting the Agricultural Reserve have continued to be created to support the preservation of agricultural and rural open space.

On March 10, 2005, Derick Berlage, Chairman of the Montgomery County Planning Board, Douglas Duncan, County Executive and Michael Knapp, County Councilmember identified the need to create a series of actions to strengthen the preservation of agricultural and rural open space. These actions included the following:

- Improving economic sustainability and profitability of agriculture
- Reducing development activity in the Rural Density Transfer Zone
- Reducing the impact of large, Private Institutional Facilities in the Rural Density Transfer Zone
- Identifying additional receiving areas for the transfer of development rights
- Expanding education awareness about the preservation of agricultural and rural open space

SUMMARY OF ACTIONS

The Community-Based Planning Division with the Research and Technology Center and the Development Review Division have been working to create a series of initiatives that will improve opportunities to preserve agricultural and rural open space. As part of this effort, the Rural Team of the Community-Based Planning Division has conducted an extensive outreach program. The initiatives are summarized in the following paragraphs:

Master Planning

During the last year, the Olney Master Plan was approved and the Planning Board Draft of the Damascus Master Plan was completed. These plans augment the actions to preserve agricultural and rural open space by increasing the level of review by the Planning Board of the proposed recommendations in these master plan areas. The Rural Density Transfer Zone continues to be used as the primary implementation tool in these planning areas. Additional parkland, Legacy Open Space easements, and techniques to preserve the Patuxent River watershed were established in each of these master plans to augment the preservation of agricultural and rural open space.



The pending Sector Plan for Shady Grove, and the master plans for Olney and Damascus identify additional receiving areas to foster the transfer of development rights to areas more appropriate for development and away from the Agricultural Reserve. These plans provide the opportunity to preserve over 5,000 acres (over 1,000 TDRs) of farmland.

TDR Status Report

The staff also completed a status report of the sending and receiving areas for the transfer of development rights. The data indicates that approximately 2,000 development rights remain to be transferred from the Rural Density Transfer Zone which reflects the preservation of 10,000 acres. The Status Report also identified that only approximately two-thirds of the TDRs identified in the master plans are actually transferred. In addition to the TDRs identified in the Olney, Damascus and Shady Grove plans, the next ten master plans need to establish an average of approximately 200 receiving rights in each plan to accommodate the remaining TDRs.

Zoning Text Amendments and Floating Zone Applications

The staff have recommended that three Zoning Text Amendments be transmitted to the County Council for introduction. These text amendments are intended to strengthen the agricultural preservation program.

- Super or Fifth TDR The Planning Board approved transmitting a text amendment that would reduce the development potential in the RDT Zone. This text amendment would provide additional incentives to increase the transfer of development rights applicable to a remaining lot.
- Eliminating the Two-thirds Requirement The Planning Board also approved transmitting a text amendment that would eliminate the existing requirement for a minimum of two-thirds of the allowable number of TDRs to be transferred in any application for development in the receiving area.
- Regulating Child Lots The staff completed a text amendment to clarify the use of the child lot provision in the Rural Density Transfer Zone.
- TDRs and Floating Zone Applications The Planning Board has recommended that applications for floating zones located outside of an existing master plan consider the use of transfer of development rights.

Private Institutional Facilities and Sand Mounds

The Planning Board discussed the use of Private Institutional Facilities and Sand Mounds in the Agricultural Reserve. Both of these initiatives are controversial. The County Council has created a task force to provide recommendations concerning the use of Private Institutional Facilities and Sand Mounds in the Agricultural Reserve. Staff will participate in each task force including the provision of economic and historical information relevant to these two issues. Staff will begin to identify opportunities to provide sites for Private Institutional Facilities in other zones near transit stations and commercial centers.



Initiatives Already Started

- TDR Tracking System Improving the maintenance of the TDR tracking system is a priority.
- Expanding TDR Capacity The staff will continue to establish new TDR receiving areas in master plans to accommodate the remaining TDRs. Staff will also explore opportunities to include TDRs in commercial zones.
- Agricultural Economics Study The Research and Technology Center is completing a report to help identify issues and opportunities for the continued viability of agriculture in Montgomery County.
- Expand the Mission of the Agricultural Farm Park The staff has begun an amendment to the Facility Plan for the Agricultural Farm Park to expand agricultural operations.

New Initiatives

The staff have recommended the following new initiatives as part of the on-going effort to improve the preservation of agriculture and rural open space:

- **Limit Development** Further limit non-agricultural uses in the RDT Zone.
- **Informational Brochure** Create a brochure and web site to identify information concerning the Agricultural Reserve in Montgomery County.
- Equestrian Easements Include equestrian easements and trails in the GIS System.
- **Increase TDR Receiving Sites** Complete a Zoning Text Amendment to increase the use of TDRs in floating zones.
