Parks Department Director's Report – Parks Department Director Michael Riley briefed the Board on the following Parks Department events and activities: the Martin Luther King, Jr. Day of Service events in the parks, during which over 200 student volunteers earned Student Service Learning credits by removing more than 11,000 pounds of trash and recyclables from eight parks; the selection of Ms. Kristi Williams as the Public Affairs and Community Partnerships Division Chief; the January 15 Council Pesticide Bill hearing, which will be followed-up with a second public hearing on February 12, with the first committee meeting in March; the County Council Artificial Turf Resolution, which seeks the use of organic alternatives to recycled rubber in the construction of artificial turf fields; the January 28 Park Foundation Board meeting and the progress in filling the vacant Executive Director position; a meeting with the Coalition for the Capital Crescent Trail to discuss the progress of a proposed joint project to construct a rest plaza north of River Road; the County Executive's recommendation on the Capital Improvements Plan (CIP), its impact on Parks Department projects, and upcoming Parks Department recommendations to the Planning Board regarding the CIP; and a proposed Spring Parks Tour for the Planning Board scheduled for late April or early May.

Research and Special Projects Division staff and Mr. Eric Smart, consultant from Bolan Smart Associates, Inc., offered a multi-media presentation and discussed the Colocation White Paper. Staff explained that colocation is the sharing of resources, such as buildings and land, by public agencies in order to more effectively provide public facilities, amenities, and services. According to Mr. Bolan, colocation of schools and parks is the most common example of this process. Colocation addresses such issues as the lack and high cost of undeveloped land, aging or obsolete facilities, the need for convenient one-stop access to multiple services, and the desire to save money and energy. Mr. Bolan offered several examples of successful colocation sites both regional and international, including the Public Safety Training Academy and Multi Agency Services Park in Montgomery County; the North Central Shared Use Facility in Regina, Saskatchewan; and Arlington Mills in Arlington County, Virginia, which combines affordable housing, a county parking garage, and a community center. Mr. Bolan noted that successful colocation sites share similar use requirements and have the ability to utilize generic designs with complementary physical features. Successful sites also require community support and executive-level commitment from governing agencies. The main issues for Montgomery County officials to consider regarding colocation are policy and planning issues, such as establishing a clear, multi-organizational colocation policy; operational issues, such as implementing default crossagency employment and procurement practices; and funding issues, such as standardizing cost benefit analyses comparing single-use facility options to colocation alternatives. The next steps in the process include a formal colocation study, the identification of key sites, the development of colocation policy guidelines, and a master plan.

There followed extensive Board discussion with questions to staff and Mr. Bolan. Vice Chair Wells-Harley, citing her previous experience with colocation in Prince George's County, reiterated the

importance of community engagement in the process and suggested the best way to achieve this engagement and garner support is by clearly showing a need for colocation projects.

Commissioner Dreyfuss noted his support for the colocation process and expressed his belief that the Commission should take the lead on this initiative.

Staff noted that only the Planning Board may file an application for a CMA.

Staff discussed each CMA separately, including site background information, the errors addressed in the CMA, and the recommended corrections.

There followed a brief Board discussion.
