In keeping with the January 13 technical staff report, Community-Based Planning and Development Review Divisions staff discussed the proposal to file a Sectional Map Amendment (SMA) for the Approved and Adopted Sector Plan for the Germantown Employment Area. Staff noted that once a master or sector plan is approved and adopted, a SMA should be filed with the District Court as required by Section 59-H-3.2 of the Zoning Ordinance.

Ms. Barbara Sears, attorney representing Foulger-Pratt Development, LLC, offered testimony.

At the Board's request, Legal Counsel to the Board offered comments.

Staff noted that the SMA will be filed in early February and the County Council will most likely set public hearing for sometime in March. Staff proposes to have the SMA finalized in early May 2010.

Chairman Hanson noted that after the Life Science Center (LSC) zone has been approved, further studies should be carried out and staff should decide whether the college property should be approved.

There followed a brief Planning Board discussion with questions to staff.

Transportation Planning staff and Environmental Planning staff presented, respectively, the mandatory referral review and forest conservation plan and requirements for proposed road improvements to re-align and widen the intersection of Brink Road and MD 355, as detailed in the two staff reports. Staff noted that the improvements will be constructed by developers to fulfill requirements associated with the Board's approval of two preliminary plans of subdivision. Staff reported that a variance has been requested as part of the forest conservation plan to remove

three specimen trees. Parks Department staff provided information about the impact of the road improvements on the abutting parkland and recommended mitigation.

The Board discussed various aspects of the project, including the functionality and appearance of the associated stormwater management facility, the desirability of abandoning all or a portion of the section of Brink Road from the new connection to MD 355 to the proposed termination just east of the existing intersection, the length of the sidewalks, and the possible need for a traffic signal at the new intersection.

Ms. Nooshin Amirpour, of the Artery Development Group, responded to questions from the Board.

Mr. Joseph Cheung, County Department of Permitting Services, and Ms. Judy Koenick offered comments on the project.

Staff offered several revisions to existing conditions and new conditions to address issues raised in discussion, which were accepted as part of the motion.

- **2. Gaithersburg West PHED Committee Update**—Community-Based Planning staff updated the Board on the status of PHED Committee review of the Gaithersburg West Master Plan. Transportation Planning staff presented proposed additional language to the Plan related to consideration of other transportation improvements as alternatives to grade-separated interchanges.
- 3. Expedited Bill 3-10 Regarding Sidewalk Construction—Transportation Planning staff briefed the Board on the Bill, which would eliminate the public hearing requirement under certain circumstances for approval of sidewalks or shared use paths, to expedite the administrative approval process. There was some discussion of ensuring adequate public notice.

  4. Growth Policy Bill 38-09 Update—Transportation Planning staff presented a draft proposal for changes to Bill 38-09, which relates to the purpose clause and timing of the Growth Policy.
