The Montgomery County Planning Board met in regular session on Thursday, March 25, 2010, at 9:40 a.m. in the Montgomery Regional Office in Silver Spring, Maryland, and adjourned at 4:37 p.m.

Present were Chairman Royce Hanson, Vice Chair Marye Wells-Harley, and Commissioner Joe Alfandre. Commissioners Norman Dreyfuss and Amy Presley were necessarily absent.

At the start of the meeting, Item 8 was discussed via telephone conference of The Maryland-National Capital Park and Planning Commission and is reported on the attached agenda.

The Board recessed for lunch at 11:15 a.m. and to take up Item 7, a Closed Session item.

- **3.
