Development Review staff offered a multi-media presentation of the request to create 108,744 gross square feet of hotel space, 6,800 gross square feet of other uses, 3,400 gross square feet of retail, and 4,800 gross square feet of restaurant on a 10.59-acre property located on West Old Baltimore Road, approximately 2,750 feet west of I-270 in Clarksburg. Staff noted that it supports the applicant's request for waivers for additional parking spaces for the hotel/restaurant and for the required 50-foot setback from the street.

Mr. Steve Elmendorf, attorney for the applicant, introduced members of the applicant's team and concurred with the staff recommendation.

There followed a brief Board discussion with questions to staff and the applicant's representative.
