The Montgomery County Planning Board met in regular session on Thursday, May 6, 2010, at 9:06 a.m. in the Montgomery Regional Office in Silver Spring, Maryland, and adjourned at 12:10 p.m.

Present were Chairman Royce Hanson, Vice Chair Marye Wells-Harley, and Commissioners Norman Dreyfuss and Amy Presley. Commissioner Joe Alfandre was necessarily absent.

Ms. Mitsuko Herrera, County Office of Cable and Communications Services, discussed the process of the Telecommunications Transmission Facility Coordinating Group ("the Tower Committee"), the anticipated number of special exception telecommunications applications in relation to those constructed by right, and the relationship of the Tower Committee to other reviewing agencies.

There followed considerable discussion of the specific process and timing proposed, as well as issues related to ensuring completeness and accuracy under the truncated system.
