Parks Department staff and staff of the Environmental Planning, Urban Design, and Transportation Planning Divisions discussed other specific issues and recommendations contained in the draft plan.

Mr. Jim Agliata, representing Westfield LLC; Mr. Danila Sheveiko of Kensington Heights; Ms. Judy Higgins, representing the Kensington View Civic Association; Ms. Virginia Sheard of Kensington View; Ms. Stephanie Savolaine of Kensington View; Ms. Heather Olhopolsky, attorney representing the Washington Property Company; and Mr. Gary Stith, County Department of General Services, offered comments.

In discussion, the Board provided guidance to staff for revisions to be incorporated into the plan prior to publication.

Development Review staff presented the proposal to resubdivide one recorded lot and one unplatted parcel to create two residential lots, as detailed in the staff report. Staff noted that the existing house will remain, with its access via River road. Access for the new lot will be provided to Persimmon Tree Road via a short extension of an existing paved private driveway within the dedicated, unbuilt right-of-way of Logan Drive. That driveway serves two houses to the south. A termination will be built to accommodate emergency vehicles, as required by County Department of Transportation (DOT).

Mr. Patrick O'Neil, attorney representing the applicant, concurred in the staff recommendation and elaborated on the proposal. Mr. O'Neil discussed a previously submitted plan with access to River Road and the proposed access via the Logan Drive right-of-way. He cited recent policy changes related to unbuilt, privately maintained public rights-of-way.

Mr. Stan Abrams, attorney representing Mr. Rafic Bizri and Mr. William Slover, adjacent property owners, spoke in opposition to the proposal, maintaining, among other arguments, that the Subdivision Regulations do not allow the proposed termination and the applicants must petition the County to abandon Logan Drive or build it to County standards.

Mr. Rafic Bizri abutting owner on Logan Drive; Mr. William Slover, adjacent property owner on River Road; Ms. Diana Conway, representing West Montgomery County Citizens Association; Ms. Kathryn Bizri, abutting owner on Logan Drive; Ms. Sandra Larey of Logan Drive; Ms. Alice Tamzarian of Logan Drive; Ms. Margaret Widmayer of Moultrie Parkway; Ms. Meredith Gobbi of Moultrie Parkway; Ms. Lois Gobbi of Moultrie Parkway; and Ms. Katherine Slover, owner abutting property on River Road, offered comments.

Mr. O'Neil responded in rebuttal testimony. Responding to the suggestion that the applicant build Logan Drive to County standards, Mr. O'Neil noted that there is no nexus to require such an improvement and DOT does not require it.

There followed considerable discussion of the issue of the proposed extension of the private driveway in the unbuilt right-of-way of Logan Drive, and the nature and characterization of the proposed terminus for emergency vehicles.

Commissioner Alfandre expressed the view that the plan is better as proposed, but he is persuaded that there is an unresolved issue about what can occur within the right-of-way.
