The Montgomery County Planning Board first met in Closed Session on Thursday, June 30, 2011, at 11:10 a.m. in the Montgomery Regional Office in Silver Spring, Maryland, and also met via conference call, both in closed and open sessions, with the Prince George's County Planning Board as The Maryland-National Capital Park and Planning Commission, and adjourned at 1:20 p.m.

The Montgomery County Planning Board met in regular session at 1:32 p.m. in the Montgomery Regional Office in Silver Spring, Maryland, and adjourned at 3:40 p.m.

Present were Chair Françoise M. Carrier, Vice Chair Marye Wells-Harley, and Commissioners Casey Anderson and Norman Dreyfuss. Commissioner Amy Presley was necessarily absent.

The Board convened in Closed Session at 11:10 a.m. in the third floor conference room, on motion of Vice Chair Marye Wells-Harley, seconded by Commissioner Dreyfuss, with Chair Carrier, Vice Chair Marye Wells-Harley, and Commissioners Anderson and Dreyfuss present and voting in favor of the motion. The meeting was closed under authority of §10-508(a)(3), State Government Article, Annotated Code of Maryland, to consider the acquisition of real property for a Commission purpose and matters directly related thereto; and §10-508(a)(1), State Government Article, Annotated Code of Maryland, to discuss the appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of Commission appointees, employees, or officials; or to discuss any other personnel matter that affects one or more specific employees.

The Board reconvened in the auditorium at 1:32 p.m.

Planning Department staff presented the PlanMaryland Draft Plan, a strategy for directing the actions of State agencies and coordinating the Smart Growth efforts of State and local governments, as detailed in the staff report, along with proposed comments. Staff noted that PlanMaryland identifies various areas in each county as Designated Places, based on information related to existing State programs and legislation, to help State agencies and local governments determine where to best focus

resources to achieve the Plan's goals and objectives. Noting that the Initial State Designations map does not include many areas designated for future growth in area master plans, staff raised concerns about future State funding decisions and presented a proposed revised map of Initial State Designations for the County that reflects master plan recommendations.

There followed considerable discussion of the areas that are not included on the Initial State Designations map and the potential impact on State funding of projects that are not within the identified Designated Places; on funding of transit projects such as Bus Rapid Transit, with routes that extend into non-priority areas; and on efforts to address other planning issues, such as jobs/housing imbalances.
