4. Suburban Hospital – <u>REVISED</u>

Development Review Division staff offered a detailed presentation, accompanied by a multi-presentation, of the special exception request for modernization and expansion of existing Suburban Hospital located on Old Georgetown Road in Bethesda, as discussed in detail in the September 15 technical staff report.

Ms. Barbara Sears, attorney representing the applicant, introduced members of the applicant's team and discussed at length the proposed request.

The Board voted in favor of the modification to the Special Exception, including revised conditions, with a vote of 3-2, with Commissioners Alfandre and Presley dissenting.
