The Montgomery County Planning Board met in regular session on Thursday, September 30, 2010, at 9:05 a.m. in the Montgomery Regional Office in Silver Spring, Maryland, and adjourned at 7:25 p.m.

The Montgomery County Planning Board convened in Closed Session at 12:40 p.m. in the third floor conference room, on motion of Commissioner Presley, seconded by Commissioner Alfandre, with Chair Carrier, Vice Chair Wells-Harley, and Commissioners Alfandre, Dreyfuss, and Presley present and voting in favor of the motion.
