The Montgomery County Planning Board met on Monday, December 8, 2008, at 6:30 p.m. in the Montgomery Regional Office in Silver Spring, Maryland, and adjourned at 10:10 p.m.

Present were Chairman Royce Hanson, Vice Chair John Robinson, and Commissioners Joe Alfandre, and Jean Cryor. Commissioner Amy Presley was necessarily absent for the Closed Session portion of the meeting and joined the meeting at 7:30 p.m.
