## RESOLUTION

WHEREAS, pursuant to Montgomery County Code Chapter 50, the Montgomery County Planning Board ("Planning Board" or "Board") is vested with the authority to review preliminary plan applications; and

WHEREAS, on March 3, 2010, First Baptist Church of Wheaton ("Applicant"), filed an application for approval of a preliminary plan of subdivision of property that would create one lot on 14.4 acres of land in the RNC zone, located at 3110 Émory Church Road ("Property" or "Subject Property"), in the Olney Master Plan area ("Master Plan"); and

WHEREAS, Applicant's preliminary plan application was designated Preliminary Plan No.120100250, First Baptist Church of Wheaton ("Preliminary Plan" or "Application"); and

WHEREAS, Planning Board staff ("Staff") issued a memorandum to the Planning Board, dated August 25, 2011, setting forth its analysis, and recommendation for approval, of the Application subject to certain conditions ("Staff Report"); and

WHEREAS, following review and analysis of the Application by Staff and the staff of other governmental agencies, on September 8, 2011, the Planning Board held a public hearing on the Application; and

WHEREAS, at the hearing, the Planning Board heard testimony and received evidence submitted for the record on the Application; and

WHEREAS, on September 8, 2011, at the conclusion of the hearing, the Planning Board voted to approve the Application subject to certain conditions, on motion of Commissioner Anderson; seconded by Commissioner Presley; with a vote of 5-0,

WHEREAS, on February 9, 2012, the Planning Board issued Resolution No. 11-76 approving the Application; and

WHEREAS, several parties filed a petition for judicial review of Resolution No. 11-76 in the Circuit Court for Montgomery County; and

WHEREAS, the Circuit Court docketed the judicial review proceeding as Southeast Olney Rural Civic Association, et al. v. The Montgomery County Planning Board, Civil No. 360396-V; and

WHEREAS, on September 10, 2012, after the filing of briefs and hearing oral argument, the Circuit Court entered a memorandum opinion and order reversing Resolution No. 11-76 and remanding this matter to the Planning Board for issuance of a resolution consistent with the Court's findings;

NOW, THEREFORE, BE IT RESOLVED, that, as required by the Circuit Court's September 10, 2012 order, and for the reasons stated in the memorandum opinion, in *Southeast Olney Rural Civic Association, et al. v. The Montgomery County Planning Board*, Civil No. 360396-V, the Montgomery County Planning Board hereby DENIES Preliminary Plan No. 120100250.
