

Summary

Section 59-7.3.3.C. of the Zoning Ordinance, states for a Sketch Plan that "the Planning Board must schedule a public hearing to begin within 90 days after the date an application is accepted. The Planning Director may postpone the public hearing by up to 30 days once without Planning Board approval. The Planning Director or applicant may request an extension beyond the original 30 days with Planning Board approval. Any extension of the public hearing must be noticed by mail and on the hearing agenda with the new public hearing date indicated".

Section 59-7.3.4.C. of the Zoning Ordinance, states for a Site Plan that "the Planning Board must schedule a public hearing to begin within 120 days after the date an application is accepted. The Planning Director may postpone the public hearing by up to 30 days once without Planning Board approval. The Planning Director or applicant may request an extension beyond the original 30 days with Planning Board approval. Any extension of the public hearing must be noticed by mail and on the hearing agenda with the new public hearing date indicated".

The Applicant has requested an extension for additional time to address issues raised at the Development Review Committee, to coordinate with review agencies, and to resubmit updated plans to all agencies. The Applicant has requested, in a letter dated August 17, 2015, that the review period for the Sketch Plan Amendment and the Site Plan be extended until December 22, 2015.

Staff recommends **approval** of this extension request.

Dear Ms. Dickel:

On behalf of Diamondback Investors, LLC (the "Applicant"), we are submitting this request for an extension of the review period for the Applications. Pursuant to Section 59-7.3.3.C of the Montgomery County Zoning Ordinance, the Montgomery County Planning Board (the "Planning Board") is required to hold a public hearing on a sketch plan application within 90 days of acceptance of the application. As a result, the Planning Board public hearing on the above-referenced Sketch Plan was tentatively scheduled for October 22, 2015. In addition, per Section 59-7.3.4.C of the Zoning Ordinance, the Planning Board is required to hold a public hearing on a site plan application within 120 days of acceptance of the application. However, as we have discussed, there is insufficient time after the Development Review Committee meeting held on August 17th for the Applicant to make and submit revisions to the Applications and to receive final agency comments in time for the October 22nd Planning Board hearing.

As a result, the Applicant is submitting this request for a 60-day extension of the review period for the Sketch Plan and a 30-day extension of the review period for the Site Plan, in order to allow the Planning Board hearing to take place on December 3rd. We also request that the Planning Board hearing on the concurrently submitted Preliminary Plan (No. 120150220) be rescheduled to the same date as the Planning Board hearing on the Applications.
