

## **Summary**

Staff Recommendation: Approval of the extension.

Section 7.3.4.C of the Zoning Ordinance provides that the Planning Board shall hold a public hearing no later than 120 days after the filing of a Site Plan. The Planning Board may, however, extend these periods. A number of design and complex interagency coordination issues related to Purple Line Station and the Capital Crescent Trail are still being resolved.
