We don't want this for Westbard as we are a suburban community (seriously... We didn't pay the big bucks for these houses so we could be in bumper to bumper traffic. We paid for quiet neighborhoods .)

Bethesda ES just added an entire additional wing to the school. Based on your downtown sector plan, you will be adding more units and this will require (more than likely) to add more trailers just to keep up with the influx to the schools. I don't want this for the Woodacres school. We are already the largest Elementary School in the county and just completed the renovation of an entire 2 story wing. They have 900 students. This is too large for an ES and critical at risk kids will get lost in the cracks. (I know this as mine did and we were granted a COSA to switch to Bethesda ES for bullying and special needs. My neighbor's son also fell through the cracks and they pulled him out and sent him to a private school.) The school is too big and kids with special needs that are not "failing enough" are not getting IEP's not the services they are required to by law. Reconsider the plan and let's do not push it past the original limit.

Please think about this before you proceed.
