

Description

Request to extend the regulatory review period for Site Plan No. 820150140 an additional 3 months to June 1, 2017.

- Residential development consisting of 6 townhouse units on 0.5 acres of land zoned RT-12.5;
- Located on Hillery Way approximately 450 feet west of Rockville Pike (MD 355) within the White Flint Master Plan area;
- Application Accepted: May 3, 2016;
- · Applicant: Alexander & Miry Livnat;
- Review Basis: Chapter 59, Montgomery County Code.



Summary

Section 59-7.3.4.C of the Zoning Ordinance generally states that a Site Plan application must be scheduled for a public hearing within 120 days after the date an application is accepted. This Application was accepted on May 3, 2016, with a tentative Planning Board date of September 8, 2016. The Applicant has made several timely requests for extensions, which were all subsequently approved by the Planning Board. The most recent extension request set a tentative Planning Board date of March 9, 2017.

During the previous review cycle, Staff determined that the Property no longer qualified for a Forest Conservation Exemption, which required the Applicant to submit an NRI/FSD and a Preliminary Forest Conservation Plan. The Applicant has since revised and resubmitted the plans and a supplemental letter of justification, including the NRI/FSD, which was approved on December 22, 2016. The Applicant is now seeking another three-month extension to allow Staff to review the latest changes and to resolve remaining issues.

Staff recommends approval of the proposed extension request, which sets a Planning Board date on June 1, 2017.
