

## Description

Location: Northwest quadrant of the intersection of Second Avenue and Apple Avenue Zone: CR 3.0, C 2.0 R 2.75, H90T and CR 5.0; C 4.0, R 4.75, H 145T Master Plan: Silver Spring CBD Sector Plan Property size: 3.62 acres Request to extend the sketch plan from September 27, 2017 to November 16, 2017. Applicant: The Housing Opportunities Commission of Montgomery County (HOC), Alexander House Development Corporation (AHDC) and Acorn Storage No 1 LLC. Acceptance Date: June 28, 2017



#### Summary

Section 59.7.3.3.C provides a 90-day limit for sketch plan hearings. The Planning Board may, however, extend this period. The Applicant requested, in an application dated August 22, 2017, that the review period for the Sketch Plan be extended from the current date of September 27, 2017 to November 16, 2017. The extension will allow the Applicant more time to address DRC comments and for a joint hearing of the applications will be more efficient. The Planning Board hearing on the application may take place before the end of the review period, and will be publicly noticed in accordance with the Zoning Ordinance. This is the first extension request associated with the subject project.

Staff recommends APPROVAL of the extension request.

The purpose of this letter is to request an extension of time for the Planning Board to consider the application listed above at a public hearing. The application was formally accepted on June 28, 2017.

The 90-day period during which the Planning Board must hold a public hearing on the Sketch Plan will expire on September 27, 2017. The Sketch Plan was filed with Preliminary Plan Amendment No. 12015003B and Site Plan No. 820170140 (collectively, the "Applications"). As this is a complicated project that includes a County Recreation and Aquatic Center, it would be in the interest of administrative economy for the Applications to be heard at the same time.
