

## **Summary**

Section 59.7.3.3.C provides a 90-day limit for sketch plan hearings. The Planning Board may, however, extend these periods. The Applicant requested, in an application dated June 5, 2017, that the review periods for the sketch plan be extended from the current date of July 13, 2017 to (and including) September 14, 2017, to allow the for a joint hearing of the Sketch Plan and the related Site Plan No. 820170100. The Applicant believes a joint hearing of the two applications will be more efficient. This is the first extension request associated with the subject project. The Planning Board hearing on the application may take place before the end of the review period, and will be publicly noticed in accordance with the Zoning Ordinance.
