

Mr. Caudle,

Thanks for your email regarding the proposed renovations to the hard surface trail in Black hill Regional Park. The existing trail was built in the early 1980's by a developer without the proper base and with too thin an asphalt layer; as a result, it has been a maintenance issue for some time.

The trail was also built well before the American with Disabilities Act (ADA) Guidelines were developed and there are several areas along the trail that are not accessible to the physically challenged. Our goal is to make as much of the trail accessible as possible. Because this is a very sensitive area environmentally, there is at least one area where we may not be able to meet the Guidelines without significant tree clearing, which we do not want to do.

As to trail widening, the trail currently ranges in width from 6'-7'. We would like to widen it, again where possible to 8'. This should be possible without additional tree clearing everywhere except perhaps where the slopes are especially steep. In these areas, our goal once again is too minimize disturbance to the trees so we will need to study these areas very carefully. The bridge is also in pretty bad shape and needs to be repaired.

I am hoping we will have a good turnout for the community meeting and hope to see you and your neighbors there. In the interim, please don't hesitate to contact me if you have additional questions.
