Action: Received Status Report No. 14 from the Intercounty Connector (ICC) Internal Review Team as an opportunity to preview the issues and preliminary staff recommendations and focus on accommodation of bicyclists in the east-west ICC corridor between Shady Grove Road and the Prince George's County line.

Noted alignment of bikeways, connectivity and access points, distance between access points, and a range of options. Endorsed the addition of cost estimates for various options, a timeline showing past and future decision points, and identification of the decision maker. Received recommendations for the Lake Frank trail connection and a report on other park-related projects, including the Trolley Museum relocation, development of a park on the Llwellyn property (as it relates to the ICC Record of Decision), and park property transfers. Noted the establishment of the task force to research and make recommendations on appropriate use of state and county resources to address the anticipated non-native invasive effects likely to be introduced due to the new forest edge created by the ICC roadway.

Concluded with a review of the ICC project schedule, including dates of future status reports.

4. Site Plan Review No. 820080070, 814 Thayer Avenue

CBD-0.5 zone; 0.64 acres; 52 multi-family dwelling units, including 7 MPDUs; located on Thayer Avenue, approximately 150 feet southeast of Fenton Street; Silver Spring *Staff recommendation: Approval with conditions*

Action: Approved staff recommendation for approval subject to conditions as modified and stated in the attached Board Resolution; directed staff to send a letter to Montgomery County Department of Transportation to convey concerns expressed in testimony about vehicular turning movements, safe access to an adjacent alley and Grove Street, and possible placement of protective bollards in the alley.

Development Review Division staff presented highlights of the April 18 technical staff report on this proposal, located on the eastern edge of the Silver Spring Central Business District, to create a five-story multi-family residential building with 52 units, 7 of which are moderately priced dwelling units (MPDUs), an on-site recreation room, and 36 on-grade parking spaces under the building. As noted in the staff report, this site plan is subject to the conditions of approval imposed on the project plan and preliminary plan, and "remains largely unchanged from those submissions."

Ms. Susan Reutershan, attorney for the applicant, introduced Mr. Harold Collins, the applicant, Ms. Meredith Byer, consulting engineer with VIKA, Inc., Mr. Matt Davitt, consulting architect, and Mr. Stan Voudrie of the applicant company. Ms. Reutershan accepted the conditions as modified. Members of the applicant's team reviewed site background, design elements, and details of the artwork designed for the plaza by artist Kari Minnick.

Ms. Jane Gorbaty of Grove Street, representing the East Silver Spring Civic Association, testified the building is beautiful, but the community has concerns that it was not part of the process and is concerned about potentially serious vehicular and pedestrian conflicts.

Ms. Reutershan offered rebuttal testimony about traffic circulation and traffic management issues.
